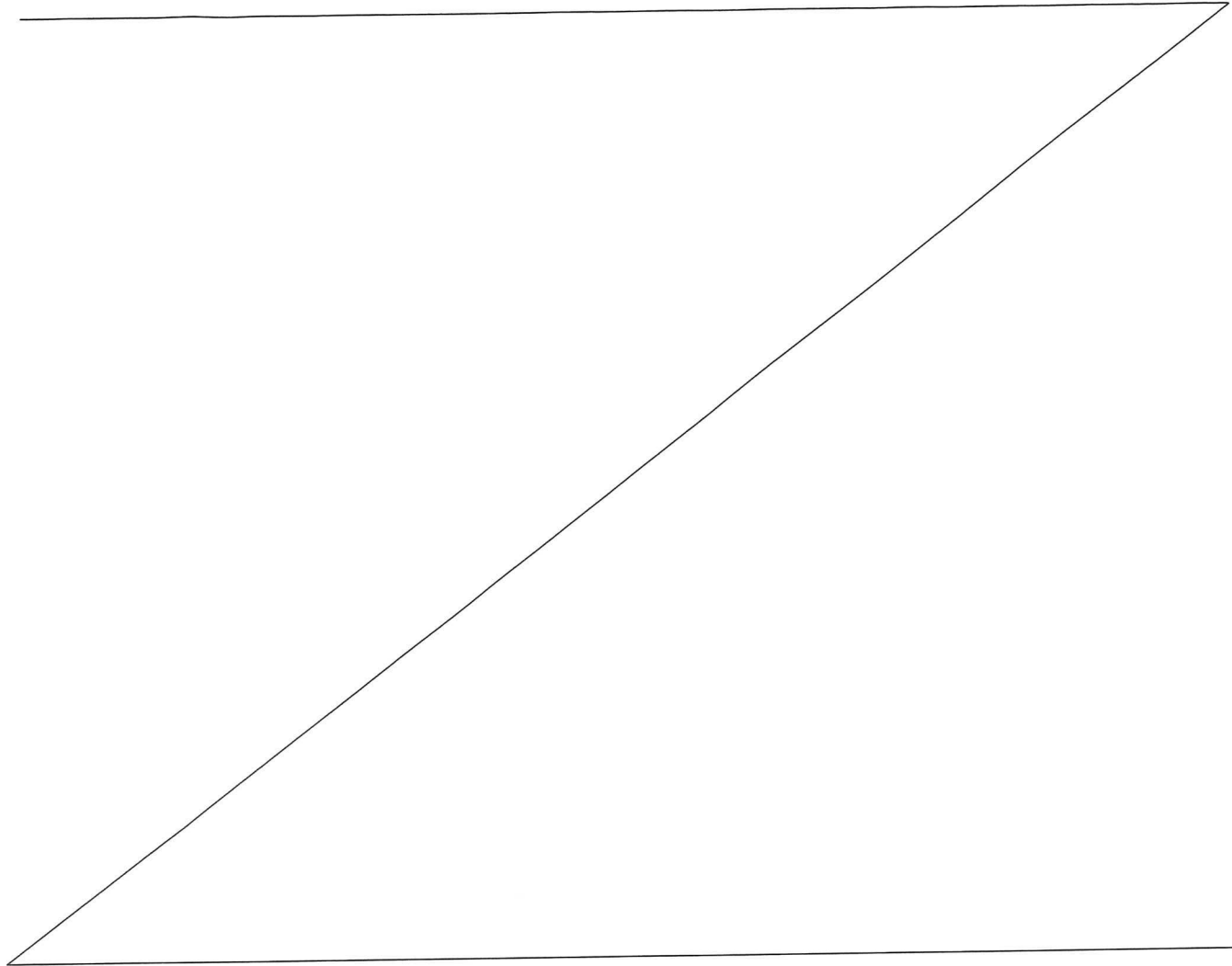
WHEREAS, the County of Nevada entered into an agreement with P31 Enterprises Inc., through Resolution 25-172, for a total of \$259,997.02 and a 10% contingency of \$25,999.70 for the contract work items, with a contract total of \$285,996.72; and

WHEREAS, said Contract for the 2025 Vegetation Removal was completed in accordance with the plans and specifications; and

WHEREAS, the improvements were completed to the satisfaction of the Nevada County Department of Public Works on January 23, 2026, with contract costs totaling \$275,392.71.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Accepts the work as being completed.
2. Directs the Clerk of the Board of Supervisors to release the Bond for Labor and Materials on April 16, 2026, and the Bond of Faithful Performance on March 10, 2027.
3. Directs the Clerk of the Board of Supervisors to record this notice in accordance with Civil Code Section 9208.
