RESOLUTION APPROVING THE EXECUTION OF AMENDMENT A.1 TO THE AGREEMENT WITH THE BEHAVIORAL HEALTH SERVICES OVERSIGHT AND ACCOUNTABILITY COMMISSION FOR THE BEHAVIORAL HEALTH STUDENT SERVICES ACT GRANT IN THE CATEGORY OF MARGINALIZED AND VULNERABLE YOUTH IN THE AMOUNT OF \$500,000 TO REVISE EXHIBIT “A”, SCHEDULE OF SERVICES AND EXHIBIT “B” SCHEDULE OF CHARGES AND PAYMENTS TO REFLECT THE RENAMING OF THE COMMISSION, TO EXTEND THE CONTRACT TERMINATION DATE FROM DECEMBER 31, 2027 TO MARCH 31, 2028, AND TO UPDATE REPORTING DUE DATES TO ALIGN WITH THE TERM EXTENSION (RES 24-619)

WHEREAS, On December 10, 2024, per Resolution 24-619, the Nevada County Board of Supervisors approved execution of agreement 24MHSOAC032 and accepted funds from the Mental Health Services Oversight and Accountability Commission (MHSOAC) for the Mental Health Student Services Act (MHSSA) in the category of Marginalized and Vulnerable Youth in the maximum amount of \$500,000; and

WHEREAS, the MHSOAC MHSSA grant has previously been awarded to the Nevada County Behavioral Health Department; and

WHEREAS, an additional round of funding (Round 4) for the MHSSA program, specifically in the category of Marginalized and Vulnerable Youth was made available to Nevada County Behavioral Health Department; and

WHEREAS, the monies awarded for this Program were used to expand the MHSSA program to provide school behavioral services to Foster Youth; and

WHEREAS, Nevada County Behavioral Health has partnered with Nevada County Superintendent of Schools to increase and provide behavioral services to Foster Youth within Nevada County Schools; and

WHEREAS, Mental Health Services Oversight and Accountability Commission (MHSOAC) has been renamed to Behavioral Health Services Oversight and Accountability Commission (BHSOAC); and

WHEREAS, the parties desire to amend their Agreement to revise Exhibit “A”, Schedule of Services and Exhibit “B”, Schedule of Charges and Payments to reflect the renaming of the Commission and to extend the contract termination date from December 31, 2027 to March 31, 2028.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Amendment A.1 to that Agreement Number 24MHSOAC032 by and between the County and the Behavioral Health Services Oversight and Accountability Commission pertaining to the Behavioral Health Student Services Act grant funds in the amount of \$500,000 for the term of December 23, 2024 (approved December 10, 2024) through March 31, 2028 be and hereby is approved in substantially the form attached hereto, and

that the Director of Behavioral Health be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.
