OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING ACCEPTANCE OF FUNDS FROM THE DEPARTMENT OF HEALTH CARE SERVICES UNDER THE CAPACITY AND INFRASTRUCTURE, TRANSITION, EXPANSION AND DEVELOPMENT (CITED) PROGRAM, FOR THE PURPOSE OF IMPLEMENTING THE TRANSITIONAL RENT BENEFIT THROUGH THE CALAIM MEDI-CAL WAIVER IN THE MAXIMUM AMOUNT OF \$190,305.49 FOR THE TERM OF JANUARY 1, 2026 THROUGH DECEMBER 31, 2026; AND AUTHORIZING THE DIRECTOR OF BEHAVIORAL HEALTH TO SIGN THIS AGREEMENT AND ALL RELATED DOCUMENTS THROUGH THE DHCS PORTAL AS REQUIRED BY THE STATE AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE BEHAVIORAL HEALTH BUDGET FOR FISCAL YEAR 2025/26 (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, on November 18, 2025, the California Department of Health Care Services (DHCS) under the CITED Program, which is part of the California Providing Access and Transforming Health (PATH) Initiative, allocated to the Nevada County Behavioral Health Department \$190,305.49 to support local implementation of the Transitional Rent benefit through the CalAIM Medi-Cal Waiver; and


WHEREAS, Transitional Rent is a Medi-Cal CalAIM waiver benefit that provides up to 6 months of rent for individuals within the behavioral health system of care who are transitioning to permanent housing; and

WHEREAS, the Nevada County Behavioral Health Department will utilize these funds to supplement staff salaries to support rolling out the newly available Transitional Rent benefit; and

WHEREAS, these funds will assist Nevada County Behavioral Health in implementing the Transitional Rent benefit locally to more effectively support people experiencing homelessness who also have mental health or substance use disorder needs.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the County is hereby authorized to accept the California DHCS funds under the CITED Program, which is part of the California PATH Initiative Round 4 funding in the maximum amount of \$190,305.49 for the term of January 1, 2026, through December 31, 2026, to approve the Terms and Conditions attached hereto, and that the Director of Behavioral Health is hereby authorized to sign the Acknowledgement and any necessary documents in connection with this Award and all amendments thereto, via the state required document portal and directs the Auditor-Controller to amend the Behavioral Health budget (4/5 affirmative vote required) for Fiscal Year 2025/26 as follows:
