OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION CERTIFYING COUNTY-MAINTAINED MILEAGE FOR 2019

WHEREAS, Section 2121 of the Streets and Highways Code provides that every year each County shall submit to the California Department of Public Works any additions and exclusions from its mileage of maintained County roads specifying the termini and mileage of each route added or deleted; and


WHEREAS, the total mileage of maintained County roads was identified as 562.10 miles in 2018; and

WHEREAS, updates to the maintained mileage list show that the current maintained mileage for 2019 is 561.84 miles, as shown in Exhibit A.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Acknowledges that last year the total mileage of maintained County roads was 562.10 miles.
- 2. Certifies the current total mileage of maintained County roads to be 561.84 miles.
- 3. Acknowledges that the adoption of this Resolution is not intended to evidence acceptance of the roads set forth herein under the provisions of the Streets and Highways Code, Section 941, or to waive its immunity provisions.

BE IT FURTHER RESOLVED AND ORDERED that duplicate copies of the hereinabove said Exhibit "A" shall be filed in the office of the Director of Public Works of the County of Nevada.
