



# RESOLUTION No. 22-155

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION ADOPTING A LIST OF PROJECTS FOR FISCAL YEAR 2022-23 FUNDED BY SB1: THE ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017

WHEREAS, Senate Bill 1 (SB1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the Governor in April 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB1 includes accountability and transparency provisions that will ensure the residents of Nevada County are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, Nevada County must adopt by resolution a list of all projects proposed to receive funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB1, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, Nevada County staff estimates the County will receive an estimated \$3,458,291 in RMRA funding in Fiscal Year 2022/23 from SB1; and

WHEREAS, SB1 funding will enable Nevada County to continue essential road maintenance and rehabilitation projects and safety improvements for the traveling public that would not have otherwise been possible without SB1; and

WHEREAS, Nevada County has undergone a public process to ensure public input into our community's transportation priorities/the project list; and

WHEREAS, Nevada County used a Pavement Management System to develop the SB1 project list to ensure revenues are being used on the most high-priority and cost-effective projects that also meet the communities' priorities for transportation investment; and

WHEREAS, the funding from SB1 will help Nevada County maintain and rehabilitate approximately 1.5 miles of roadway throughout Nevada County, provide vegetation management on approximately 24 miles of road and provide drainage and shoulder maintenance on numerous roads; and

WHEREAS, the 2018 California Statewide Local Streets and Roads Needs Assessment found that Nevada County's roads are in an "at-risk" condition and this revenue will help us increase the overall quality of our road system and over the next decade will bring our streets and roads into a "good" condition; and

WHEREAS, the SB1 project list and overall investment in our local road's infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using cutting-edge technology, materials, and practices, will have significant positive co-benefits statewide.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Nevada County Board of Supervisors, as follows:

1. The foregoing recitals are true and correct.
2. The following list of proposed projects, will be funded in-part or solely with fiscal year 2022-23 Road Maintenance and Rehabilitation Account revenues:

a. **Project Title: Road Maintenance and Rehabilitation Program – 2022 Overlay and Pavement Rehabilitation**

Project Description: This project will repave approximately 2 miles of roads in Nevada County.

Project Location: The following location identified is an estimate and has yet to be finalized:

DOG BAR RD	WOLF CREEK	MISTY WINDS LANE

Proposed Project Schedule: Work will occur between June 15, 2022, and Dec 30, 2022.

Useful Life: 15-20 years for repaving.

b. **Project Title: Road Maintenance and Rehabilitation Program – 2022 Brushing, Shoulder, General Maintenance Project**

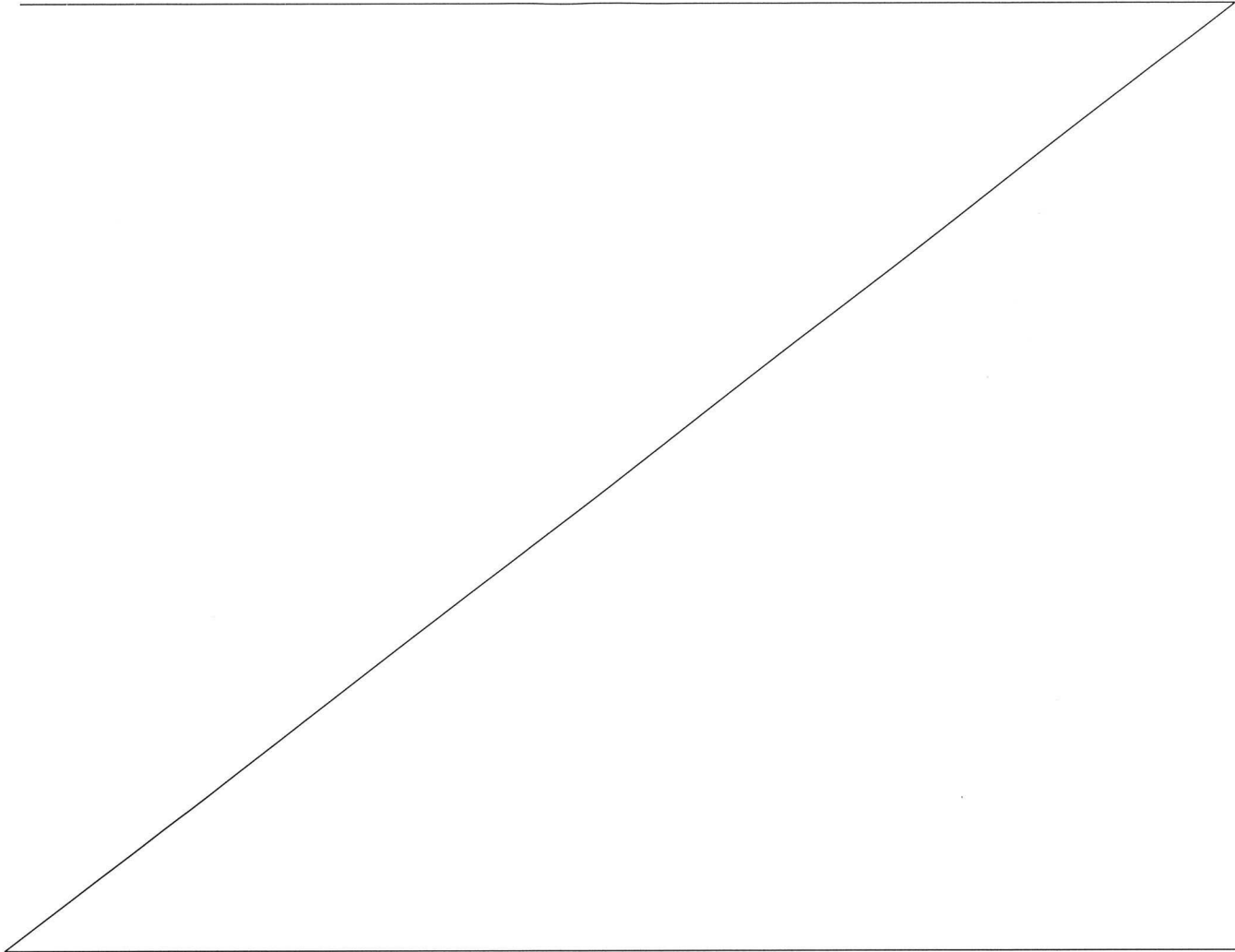
Project Description: This project will provide vegetation management along approximately 24 miles of county roads and shoulder and general maintenance throughout Nevada County.

Project Location: Shoulder and general maintenance will occur throughout unincorporated Nevada County. The following vegetation management locations identified are an estimate and have yet to be finalized:

Proposed Project Schedule: Work will occur between June 15, 2022, and July 1, 2023

Useful Life: Vegetation, shoulder and general maintenance work can have a 1-5-year useful life.
