**RECOMMENDATION:** Approve the appointment to the First 5 Nevada County Children and Families First Commission of Eli Gallup as “Member representing interest of local school districts”, for an unexpired two-year term ending February 28, 2028, and reappointment of Bobbi Luster as "Greater Truckee Area member representing interests of children", for an unexpired two-year term ending October 31, 2027.

**FUNDING:** N/A

**BACKGROUND:** Currently there are four vacancies for the First 5 Nevada County Children and Families First Commission. One vacancy for “member representing the interests of children” in the Greater Truckee Area for a two-year term expiring October 31, 2027, one vacancy for “member representing interest of local school districts” for a two-year term ending February 28, 2028. Two vacancies for alternate community representative to serve at the pleasure of the board. These vacancies were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers bulletin board, the Board of Supervisors office, and the County website. Notice was also posted at the Truckee Town Hall and the District V Board of Supervisors office in Truckee.

Eli Gallup submitted an application for this position on April 30, 2026. Melody Easton, Executive Director of First 5 Nevada County, and Supervisor Tucker recommend the appointment of Eli Gallup to the Commission.

Bobbi Luster submitted an application for reappointment on April 30, 2026. Bobbi has served on the Commission since April 23, 2024, and is a member in good standing.
