BACKGROUND:

Currently, there are two vacancies and four positions for the Nevada County Mental Health and Substance Use Advisory Board. One vacancy to fill an unexpired three-year term ending June 30, 2023 and one vacancy for three-year term ending June 30, 2025. Four positions available to fill three-year terms ending June 30, 2025. The vacancies and positions can be filled by Consumer, Family or General Members. These vacancies and positions were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers bulletin board, the Board of Supervisors office, and the County website. Notice was also posted at the Truckee Town Hall and the District V Board of Supervisors office in Truckee.

Sam Sebastian Echeverria submitted an application for the reappointment to the Nevada County Mental Health and Substance Use Advisory Board on April 19, 2022. Sam was first appointed to the Board on February 9, 2021.

Lori Malone submitted an application for reappointment to the Nevada County Mental Health and Substance Use Advisory Board on May 25, 2022. Lori was first appointed to the Board on January 8, 2019.

Laura Preston submitted an application for reappointment to the Nevada County Mental Health and Substance Use Advisory Board on May 26, 2022. Laura was first appointed to the Board on July 14, 2015.
