RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 3 TO THE CONTRACT WITH GLENNAH TROCHET, M.D. PERTAINING TO INTERIM PUBLIC HEALTH OFFICER DUTIES AS REQUIRED BY THE NEVADA COUNTY PUBLIC HEALTH DEPARTMENT DURING ABSENCES OR UNAVAILABILITY OF THE COUNTY PUBLIC HEALTH OFFICER TO INCREASE THE HOURLY RATE FROM \$145 TO \$150 (AN INCREASE OF \$5/HR) EFFECTIVE MARCH 1, 2021, TO MATCH THE PUBLIC HEALTH OFFICER'S HOURLY RATE, AND REVISING EXHIBIT "B", SCHEDULE OF CHARGES AND PAYMENTS TO REFLECT THE INCREASE IN THE HOURLY RATE. (PESO3993) (RES 20-473)

WHEREAS, on July 13, 2020, per Purchasing Contract Number PESO3993, the Nevada County Purchasing Agent authorized the execution of the Renewal Professional Services Agreement in the amount of \$14,500, with Dr. Glennah Trochet, MD, which was subsequently amended on October 15, 2020 to increase the maximum contract amount to \$50,000, to serve as the Acting Public Health Officer and Acting Registrar on an interim basis for the County of Nevada when the appointed Health Officer is absent or otherwise unavailable to carry out his/her duties as required by law; and

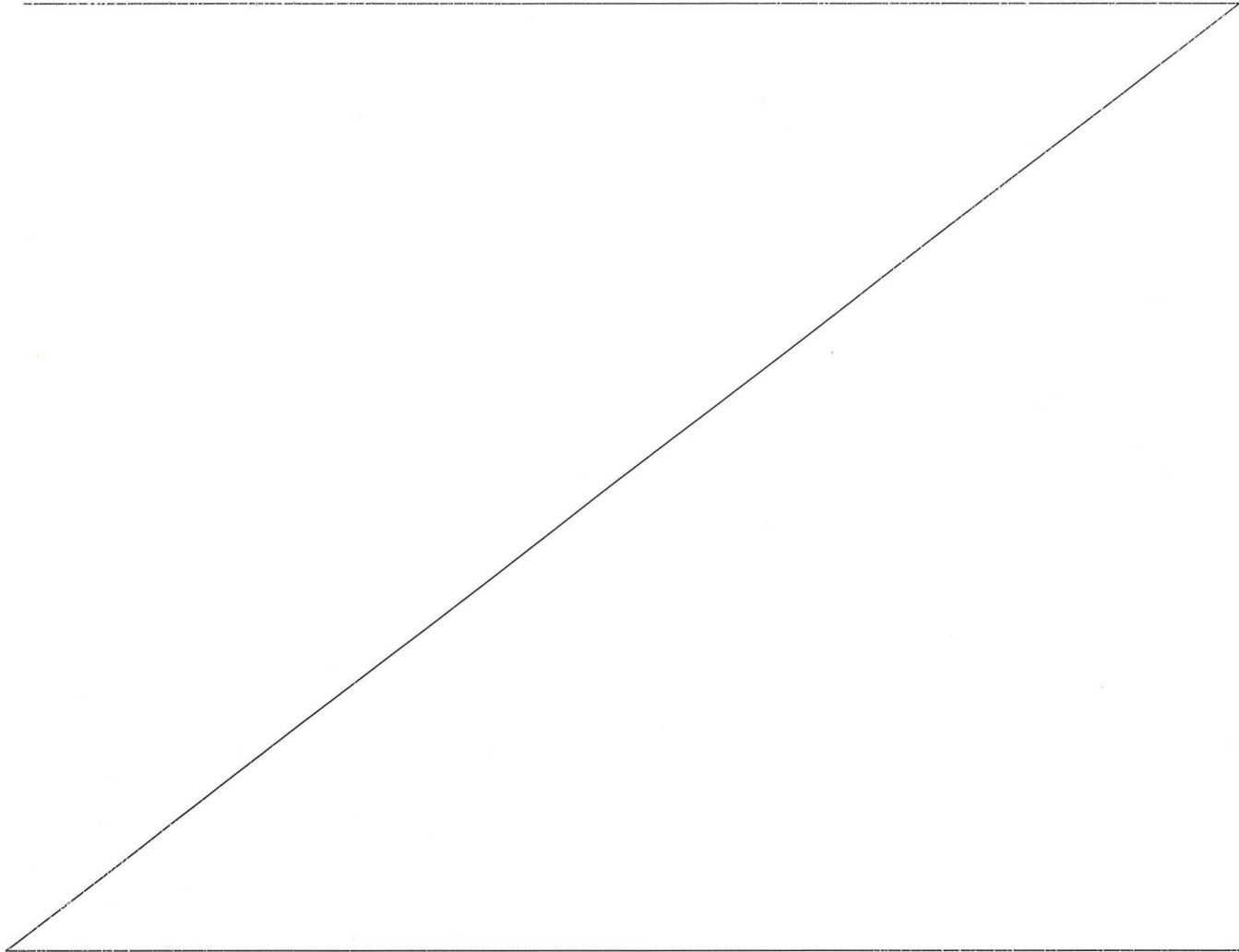
WHEREAS, RES 20-473, was approved the Nevada County Board of Supervisors on November 13, 2020, to increase the maximum contract price from \$50,000 to \$130,000 (an increase of \$80,000), as the need for additional Public Health Officer and Registrar services has increased due to the COVID-19 pandemic; and

WHEREAS, the Parties desire to Amend their Agreement to increase the hourly rate from \$145 per hour to \$150 per hour (an increase of \$5/HR) effective March 1, 2021, to match the hourly rate of the Public Health Officer; and

WHEREAS, Exhibit "B" Schedule of Charges and Payments, has been revised to reflect the increase in the maximum contract price.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California that the Amendment No. 3 to the Professional Services Agreement by and between the County and Glennah Trochet, M.D. for the provision of interim Public Health Officer and Registrar services required by the Nevada County Public Health Department for the term of July 1, 2020, through June 30, 2022, in the maximum amount of \$130,000 be and is hereby approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.

**AMENDMENT #3 TO THE RENEWAL CONTRACT
WITH GLENNAH TROCHET, M.D.
(PESO3993) (RES 20-473)**

THIS AMENDMENT is executed this April 13, 2021 by and between GLENNAH TROCHET, M.D., hereinafter referred to as "Contractor" and COUNTY OF NEVADA, hereinafter referred to as "County". Said Amendment will amend the prior Agreement between the parties entitled Personal Services Contract, executed on July 13, 2020 per Purchase Order No. PESO3993 and amended on October 15, 2020; and subsequently amended on November 10, 2020 (RES 20-473).

WHEREAS, the Contractor provides services pertaining to interim Public Health Officer and Registrar services for the County of Nevada during absences or unavailability of the County Public Health Officer; and

WHEREAS, the parties desire to amend their Agreement to increase the hourly rate from \$145 per hour to \$150 per hour (an increase of \$5/HR) and revise Exhibit "B" Schedule of Charges and Payments to reflect the increase in the hourly rate. The maximum contract price of \$130,000 will remain the same.

NOW, THEREFORE, the parties hereto agree as follows:

1. That Amendment #3 shall be effective as of March 1, 2021.
2. That the maximum contract price shall remain the same.
3. That the hourly rate will increase from \$145/hr to \$150/hr (an increase of \$5/hr).
4. That the Schedule of Charges and Payments, Exhibit "B" is amended and replaced in its entirety as set forth in the revised Exhibit "B" attached hereto and incorporated herein.
5. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.

EXHIBIT "B"
SCHEDULE OF CHARGES AND PAYMENTS
GLENNAH TROCHET, MD

The maximum contract obligation for services provided under this Contract shall not exceed \$130,000 for the entire contract term of July 1, 2020 through June 30, 2022.

County shall reimburse Contractor at the rate of \$145 per hour from July 1, 2020, through February 28, 2021, and at the rate of \$150 per hour from March 1 through June 30, 2021. Contractor agrees to bill in the minimum of fifteen (15) minute increments. County agrees to pay Contractor a flat fee for any consecutive period of up to seven (7) days, in which Contractor agrees to be "on call" and available, if necessary, to provide services to Nevada County, whether or not Contractor is actually called upon to render services. The flat fee will be the same as the hourly rate in effect on that date. For periods of "on call" that are more than seven (7) consecutive days, Contractor will bill at the flat fee in effect on that date for the additional period in increments of up to seven (7) days each.

Contractor shall be reimbursed for mileage at the current IRS mileage rate per mile for trips made in Contractor's car when Contractor is required by Department to travel in order to provide services.

Contractor shall submit a monthly invoice at the end of each month for compensation and mileage to be reimbursed. The invoice shall be delivered or mailed to:
