APPROVAL OF APPLICATION FOR \$609,881 IN FISCAL YEARS 2010/11 AND 2014/15 PROPOSITION 1B, PUBLIC TRANSPORTATION MODERNIZATION, IMPROVEMENT, AND SERVICE ENHANCEMENT ACCOUNT (PTMISEA) FUNDING APPORTIONED BY THE CALIFORNIA DEPARTMENT OF TRANSPORTATION

WHEREAS, the Proposition 1B, Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA) Fiscal Years 2010/11 and 2014/15 provides revenue apportionments for Nevada County which may be used for eligible capital projects included in the Western Nevada County Transit Development Plan Update and the Western Nevada County Coordinated Public Transit-Human Services Transportation Plan Update; and

WHEREAS, Transit Services Facilities and bus stop improvements are eligible projects for Proposition 1B PTMISEA funding included in the Western Nevada County Transit Development Plan and the Western Nevada County Coordinated Public Transit-Human Services Transportation Plan Update; and


WHEREAS, Transit Services will be submitting a \$609,881 allocation request for two capital projects including revenue for transit facility construction costs at the new Nevada County Operations Center in the amount of \$500,000 and the multi-phase Bus Stop Improvement Project to identify and improve accessibility and safety at bus stops throughout the Gold Country Stage service area in the amount of \$109,881; and

WHEREAS, it is necessary for the Board of Supervisors to approve the Application for Fiscal Years 2010/11 and 2014/15, Proposition 1B, PTMISEA funds for capital projects to improve Transit Services Facilities and Gold Country Stage bus stops in the amount of \$609,881; and

WHEREAS, funds shall be deposited into Transit Services Fund 4281-91003-707-1000/442940.
