



RESOLUTION No. 26-228

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 2 TO LEGAL SERVICES AGREEMENT FOR LITIGATION SERVICES BETWEEN THE COUNTY OF NEVADA AND JONES MAYER, EXTENDING THE TERM OF THE AGREEMENT TO JUNE 30, 2027, AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE AMENDMENT

WHEREAS, effective April 7, 2023, Nevada County executed a Legal Services Agreement with Jones Mayer for litigation services related to civil nuisance abatement, civil injunction, potential receivership services, and such other matters; and

WHEREAS, the Agreement was for a maximum amount of \$50,000 with a term to June 30, 2024; and

WHEREAS, the cases were on-going, and the Agreement term was extended from June 30, 2024, to June 30, 2026, and the maximum amount increased to \$170,000; and

WHEREAS, Nevada County desires that the Contractor continue to provide legal services related to the continued defense and trial of the above-referenced claims and litigation, and Contractor is ready, willing and able to provide such services; and

WHEREAS, the parties again desire to extend the term of the Agreement from June 30, 2026, to June 30, 2027; and

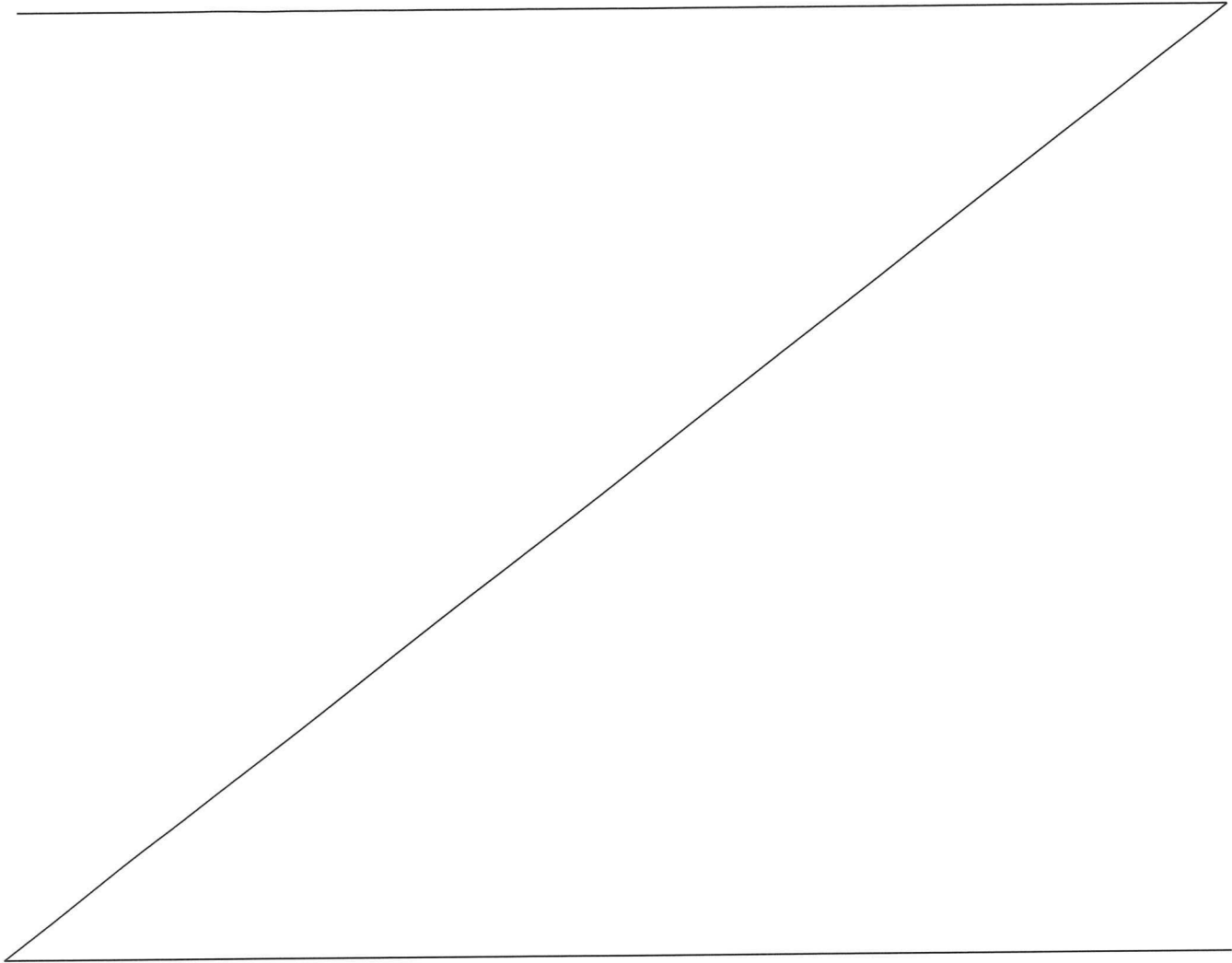
WHEREAS, the Agreement is funded by the Code Compliance budget; and,

WHEREAS, the Amendment is contingent upon the adoption of the Fiscal Year 2026/27 County budget; and,

WHEREAS, this Amendment shall begin on July 1, 2026.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada:

1. Amendment No. 2 to the Legal Services Agreement by and between the County of Nevada and Jones Mayer, extending the term of the agreement from June 30, 2026, to June 30, 2027, is hereby approved in the form attached hereto as Exhibit A.
2. The Chair of the Board of Supervisors is hereby authorized to execute the Amendment.
3. Authorizes the Purchasing Agent to encumber the remaining balance for Fiscal Year 2026/27: FD1119 - CC20709 - PG3241119 - 99900020 - SC21520
