



# RESOLUTION No. 22-271

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION APPROVING A THREE-MONTH CONTRACT EXTENSION, JULY 1, 2022 TO SEPTEMBER 30, 2022, TO AMENDMENT NUMBER 9 TO THE AGREEMENT BETWEEN THE COUNTY OF NEVADA AND PARATRANSIT SERVICES FOR THE PROVISION OF SPECIALIZED PARATRANSIT SERVICES IN WESTERN NEVADA COUNTY

WHEREAS, on May 14, 2013, the Nevada County Board of Supervisors adopted Resolution No. 13-168, approving a five-year contract with Paratransit Services for provision of specialized Paratransit Services in western Nevada County that began on July 1, 2013, and will expire on June 30, 2018; and

WHEREAS, on July 22, 2014, the Nevada County Board of Supervisors adopted Resolution No. 14-362 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, on August 11, 2015, the Nevada County Board of Supervisors adopted Resolution No. 15-392 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, on July 26, 2016, the Nevada County Board of Supervisors adopted Resolution No. 16-381 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, on October 11, 2016, the Nevada County Board of Supervisors adopted Resolution No. 16-491 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, on August 15, 2017, the Nevada County Board of Supervisors adopted Resolution No. 17-438 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, on July 17, 2018, the Nevada County Board of Supervisors adopted Resolution No. 18-375 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, the contract term is five-years and commences on July 1, 2013, with a termination date of June 30, 2018; and

WHEREAS, the contract term may be extended for two, two-year periods upon approval of the Transit Services Commission and the Board of Supervisors; and

WHEREAS, on July 17, 2018, the Nevada County Board of Supervisors adopted Resolution No. 18-375 approving a two-year extension to the contract between Nevada County and Paratransit Services from July 1, 2018, through June 30, 2020; and

WHEREAS, on June 23, 2020, the Nevada County Board of Supervisors adopted Resolution No. 20-261 approving an amendment to the contract between Nevada County and Paratransit Services approving the second two-year extension from July 1, 2020, through June 30, 2022; and

WHEREAS, on July 13, 2021, the Nevada County Board of Supervisors adopted Resolution No. 21-302 approving an amendment to the contract between Nevada County and Paratransit Services; and

WHEREAS, delays in the release of Request for Proposals No. 158064 necessitate additional time be allocated to potential proposers for the development and submission of proposal responses; and

WHEREAS, Nevada County and Paratransit Services wish to amend the contract agreement for three-months from July 1, 2022, to September 30, 2022, to accommodate the additional time required to respond to the Request for Proposals and to maintain operational consistency; and

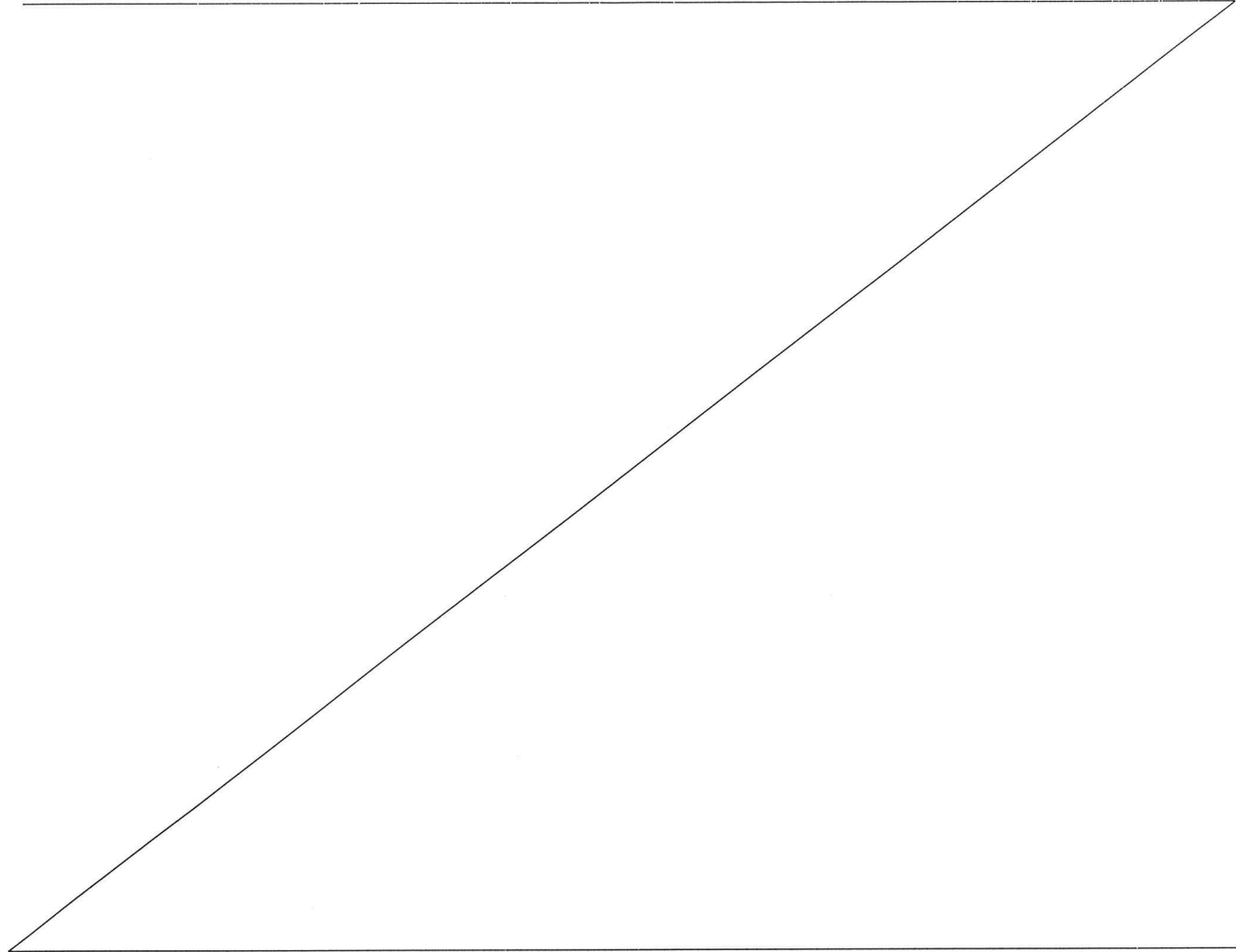
WHEREAS, Nevada County and Paratransit Services agree to maintain Paratransit Services' fixed vehicle service hourly rate of \$45.97 and the fixed monthly rate of \$64,562 as adopted by Resolution No. 21-302 per mutual agreement in Amendment No. 9 for the term of this extension July 1, 2022, through September 30, 2022.

WHEREAS, there is sufficient budget available in the proposed Fiscal Year 2022-23 Transit Services budget in account 4281-91003-707-1000/521520 to fund the contract; and

WHEREAS, the contract is contingent upon the adoption of the Fiscal Year 2022/23 County Budget.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Approves the extension of Amendment No. 9 between Nevada County and Paratransit Services for a period of three-months from July 1, 2022, to September 30, 2022.
2. Maintains the Paratransit Services' fixed vehicle service hourly rate of \$45.97 and the fixed monthly rate of \$64,562 as specified in Amendment No. 9 for the duration of the extension beginning July 1, 2022, through September 30, 2022.
3. Authorizes the Chair of the Board of Supervisors to execute on behalf of Nevada County the amendment between Nevada County and Paratransit Services.

AMENDMENT NO. 9

PARATRANSIT SERVICES CONTRACT


THIS AMENDMENT is executed this 14<sup>th</sup> day of June 2022, by and between PARATRANSIT SERVICES and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled Personal Services Contract between County of Nevada and Paratransit Services for Provision of Specialized Paratransit Services in western Nevada County, executed on July 1, 2013, by Resolution No. 13-168 and which agreement was subsequently amended on July 22, 2014, by Resolution Number 14-362, on August 11, 2015, by Resolution Number 15-392, on July 26, 2016, by Resolution No. 16-381, on October 11, 2016, by Resolution No. 16-491, on August 15, 2017, by Resolution No. 17-438, on July 17, 2018, by Resolution No. 18-375, on August 27, 2019, by Resolution No. 19-481, on June 23, 2020, by Resolution No.20-261, and on July 13, 2021, by Resolution No. 21-302.

NOW, THEREFORE, the parties hereto agree as follows:

1. To extend the agreement for a period of three months, July 1, 2022, to September 30, 2022, to provide sufficient time for the Contractor to respond to RFP No. 158064.
2. To maintain Paratransit Services' fixed vehicle service hourly rate of \$45.97 and the fixed monthly rate of \$64,562, as designated by Resolution No. 21-302, from July 1, 2022, through September 30, 2022.
3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
