

## RESOLUTION No.

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING THE NOTICE OF ACCEPTANCE AND COMLETION OF THE CONTRACT WITH MAXWELL ASPHALT INC. FOR THE TAXIWAY A AND RAMPS 1, 2, AND 5 PAVEMENT REHABILITATION PROJECT AT THE NEVADA COUNTY AIRPORT WITH CONTRACT COSTS TOTALING \$297,446.87, DIRECTING THE CLERK OF THE BOARD TO RECORD THE NOTICE IN ACCORDANCE WITH CIVIL CODE SECTION 9208 AND AUTHORIZING THE AIRPORT MANAGER TO **EXECUTE FEDERAL AND STATE GRANT** REIMBURSEMENT **DOCUMENTS** RELATED TO THE PAVEMENT REHABILITATION PROJECT

WHEREAS, the County of Nevada entered into a Standard Public Works Contract with Maxwell Asphalt Inc. per Resolution 22-433, totaling \$297,446.87 inclusive of contingency; and

WHEREAS, said Contract was for the Taxiway A and Ramps 1, 2, and 5 Pavement Rehabilitation Project in accordance with the plans and specifications; and

WHEREAS, said improvements were completed to the satisfaction of the Nevada County Airport Manager and Brandly Engineering on November 1, 2023; and

WHEREAS, the FAA Airport Improvement Program (AIP) will fund 90% of the cost of the construction of the Taxiway A and Ramps 1, 2, and 5 Pavement Rehabilitation Project; and

WHEREAS, the application for CALTRANS Division of Aeronautics AIP matching grant is contingent upon the award of a FAA grant and would fund 4.5% of the Taxiway A and Ramps 1, 2, and 5 Pavement Rehabilitation Project; and

WHEREAS, upon inspection of the completed Pavement Rehabilitation Project the total contract costs came to \$220,569.

NOW, THEREFORE BE IT RESOLVED by the Board of Supervisors of the County of Nevada, State of California, hereby:

- 1. Accepts the work as being completed for the Taxiway A and Ramps 1, 2, and 5 Pavement Rehabilitation Project.
- 2. Directs the Clerk of the Board to release the Bond for Labor and Materials on March 26, 2024, and the Bond of Performance on December 6, 2024.
- 3. Directs the Clerk of the Board to record this notice in accordance with Civil Code Section 9208.

4. Authorizes the Airport Manager to execute Federal Aviation Administration and Caltrans Division of Aeronautics State Matching Grant reimbursement documents related to Taxiway A and Ramps 1, 2, and 5 Pavement Rehabilitation Project.

BE IT FURTHER RESOLVED THAT the Auditor-Controller is hereby authorized and directed to release and pay the remaining retention of \$12,643.45, thirty-five (35) days after the recording of the Notice of Completion, or no later than sixty (60) days after completion of the project as defined in PCC Section 7107, whichever occurs first, to assure that there are no Stop Payment notices filed against the project.
