
RESOLUTION TO APPROVE THE NOTICE OF ACCEPTANCE AND COMPLETION OF THE CONTRACT BETWEEN THE COUNTY OF NEVADA AND SIERRA ASPHALT, INC. OF RANCHO CORDOVA, CA FOR THE REHABILITATION AND SEALING OF THE COUNTY GOVERNMENT CENTER CAMPUS PARKING AREAS AND SERVICE ROADS PROJECT, LOCATED AT 950 MAIDU AVENUE, NEVADA CITY, CA, AUTHORIZING THE CLERK OF THE BOARD TO RECORD A NOTICE IN ACCORDANCE WITH CIVIL CODE SECTION 9208

WHEREAS, Nevada County Purchasing conducted a competitive bidding process for the Rehabilitation and Sealing of the County Government Center Campus Parking Lots and Service Roads, with the Nevada County Board of Supervisors awarding the contract to Sierra Asphalt, Inc. (RES 25-369); and

WHEREAS Sierra Asphalt, Inc. performed the contracted services, at the contracted cost of \$384,400, with no change order requests.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Authorizes the County Clerk of the Board to record a notice in accordance with Civil Code Section 9208.
- 2. Authorize the release of Material Bonds on November 14, 2025, and Performance bonds on October 15, 2026.
