OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 2 TO THE CONTRACT WITH AEGIS TREATMENT CENTERS, LLC. FOR THE PROVISION OF A DRUG MEDI-CAL OUTPATIENT NARCOTIC TREATMENT PROGRAM FOR BEHAVIORAL HEALTH CLIENTS TO INCREASE THE MAXIMUM AMOUNT FROM \$826,000 TO \$851,000 (AN INCREASE OF \$25,000) FOR FY 2023/24 AND REVISE EXHIBIT "B" TO REFLECT THE INCREASE IN THE MAXIMUM CONTRACT PRICE. (RES. 23-389) (RES. 24-001)

WHEREAS, on August 8, 2023, per Resolution 23-389, the Nevada County Board of Supervisors authorized the execution of the Professional Services Contract between the County of Nevada and Aegis Treatment Centers, LLC for Drug Medi-Cal (DMC) outpatient Narcotic Treatment Program (NTP) for referred clients of the Nevada County Behavioral Health Department and subsequently amended this item on January 9, 2024 per Resolution 24-001; and

WHEREAS, opioid abuse is a significant challenge for our community, with the rate of opioid prescriptions as well as opioid overdose emergency department visits exceeding the state rate significantly; and

WHEREAS, Contractor has locations in Marysville and Grass Valley that Nevada County Drug Medi-Cal (DMC) beneficiaries receive Opioid Use Disorder medication assisted treatment and counselling; and

WHEREAS, pursuant to DMC-ODS, Nevada County is required to contract with an organization that provides a Narcotic Treatment Program; and

WHEREAS, this contract enables Nevada County DMC beneficiaries to receive Narcotic Treatment Program services locally and in neighboring counties and enable Nevada County to be compliant with DMC-ODS requirements.

WHEREAS, the parties desire to amend their agreement to increase the contract price from \$826,000 to \$851,000 (an increase of \$25,000), and amend Exhibit "B" Schedule of Charges and Payments to reflect the increase in the maximum contract price.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. 2 to the Professional Services Contract by and between County of Nevada and Aegis Treatment Centers, LLC., for the provision of a Drug Medi-Cal (DMC) outpatient Narcotic Treatment Program (NTP) for referred Behavioral Health clients for the contract term of July 1, 2023 through June 30, 2024, in the maximum amount of \$851,000 be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.
