WHEREAS, the County of Nevada entered into Contract No. 224031 with Q&D Construction Inc. on May 9, 2017 by Resolution 17-201 for a contract totaling \$2,555,075 plus a 10% contingency of \$255,507.5 for the contract work items, for a maximum not to exceed amount of \$2,810,582.5; and

WHEREAS, said Contract was for the 2017 Western County Bridge Project and was constructed in accordance with the plans and specifications; and

WHEREAS, the improvements were completed to the satisfaction of the Nevada County Department of Public Works on December 15, 2017 with contract costs totaling \$2,609,113.10.

2. Directs the Clerk of the Board of Supervisors to release the Bond for Labor and Materials on March 21, 2018 and the Bond of Faithful Performance in February 13, 2019.


