



RESOLUTION No. 19-289

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 2 TO THE PERSONAL SERVICES CONTRACT BETWEEN THE COUNTY OF NEVADA AND THE BOLAND GROUP, INC., DBA OUT OF SIGHT CLEANING FOR JANITORIAL SERVICES AT VARIOUS COUNTY FACILITIES, INCREASING THE CONTRACT AMOUNT BY \$50,000 FOR A MAXIMUM CONTRACT PRICE OF \$180,000, EXTENDING THE TERM OF THE CONTRACT TO OCOBER 31, 2019, AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE AMENDMENT

WHEREAS, janitorial services are essential to the health and safety of County facilities and the Nevada County Purchasing Agent and Auditor/Controller have determined the most efficient way to procure and process payments for janitorial services on behalf of all departments is through a single master contract; and

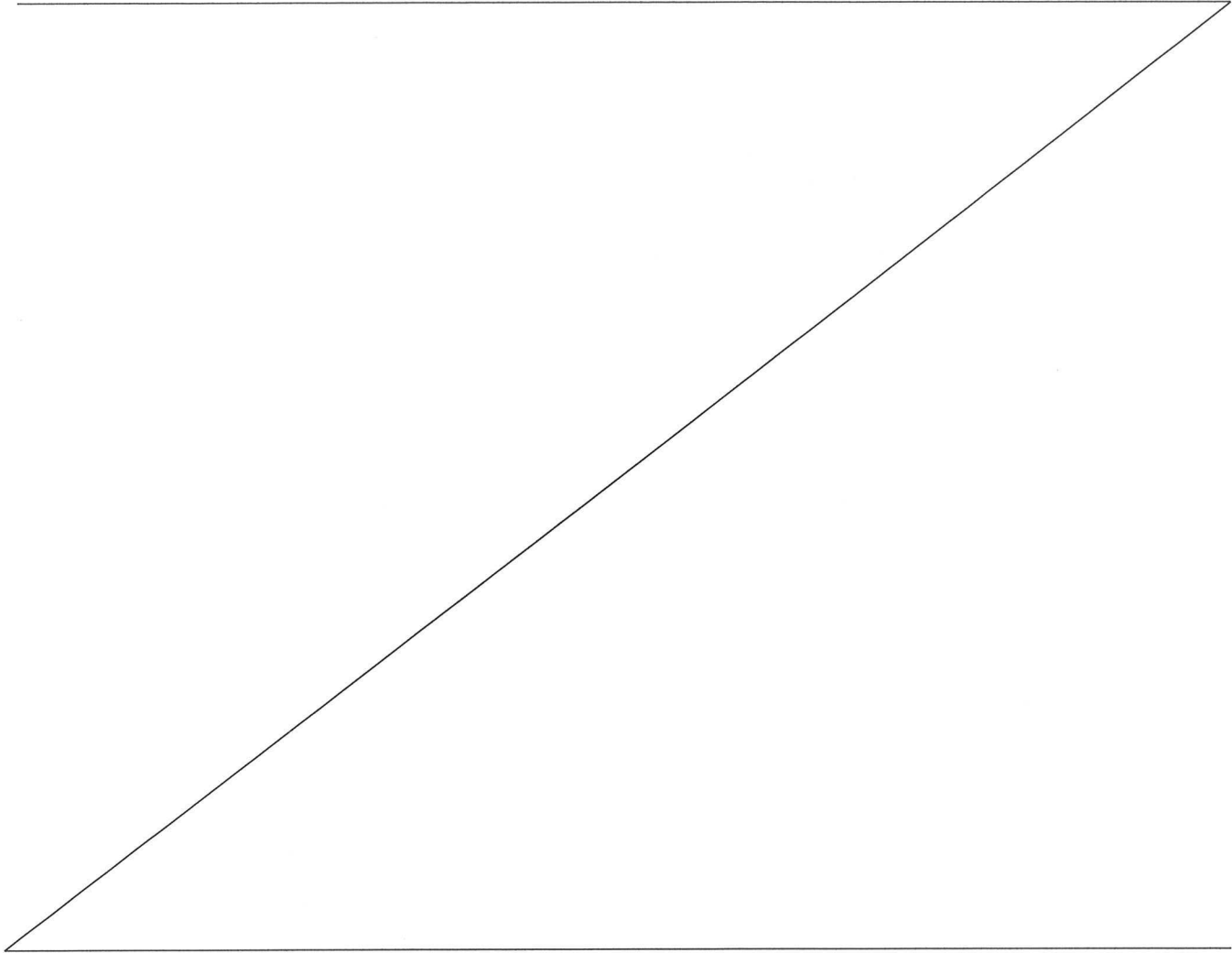
WHEREAS, Resolution 18-320 authorized a contract with The Boland Group, Inc., dba Out of Sight Cleaning to provide services for the period July 1, 2018 through December 31, 2018 and subsequently amended through Resolution 18-600 to extend the term through June 30, 2019; and

WHEREAS, the Airport no longer requires janitorial services and this location will be deleted from Exhibits A and B; and

WHEREAS, the Purchasing Agent requires more time to consult with departments concerning their current and future janitorial needs before issuing a Request for Proposals.

NOW, THEREFORE, BE IT RESOLVED that the Nevada County Board of Supervisors hereby directs that:

1. The Board approves and the Board Chair is authorized to execute Amendment No. 2 to the Personal Services Contract by and between the County of Nevada and The Boland Group, Inc., dba Out of Sight Cleaning for janitorial services at various County facilities.
2. The Maximum Contract Price of \$130,000 is increased by \$50,000 to \$180,000.
3. The Contract Termination Date is extended to October 31, 2019.
4. Janitorial services at the Airport location are no longer required and are deleted from Exhibits A and B.
5. In all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.

**AMENDMENT NO. 2 TO CONTRACT PESMB320 WITH
THE BOLAND GROUP, INC., DBA OUT OF SIGHT CLEANING**

THIS AMENDMENT is executed this 18TH day of June, 2019, by and between THE BOLAND GROUP, INC. dba Out of Sight Cleaning and COUNTY OF NEVADA. Said Amendment will amend the prior agreement between the parties entitled PROFESSIONAL JANITORIAL SERVICES FOR VARIOUS COUNTY OF NEVADA FACILITIES executed on July 23, 2018, Resolution 18-320 and subsequently amended December 11, 2018, Resolution 18-600.

WHEREAS, the parties desire to amend their agreement to provide cleaning services for four additional months except as amended herein through October 31, 2019.

NOW, THEREFORE, the parties hereto agree as follows:

1. That page 1 (§2) Maximum Contract Price of \$130,000 be increased by \$50,000 to \$180,000.
2. That page 1 (§3) Contract Termination Date be extended by four months to October 31, 2019.
3. That **Exhibit A Schedule paragraph D. Work Locations and Scheduling** be amended to delete the Airport from the Transit/Airport location as follows:

Nevada County Transit

13081 John Bauer Ave, Grass Valley, CA – 748 sq ft

Service: 1 day per week – Sunday

4. That **Exhibit B Schedule of Charges and Payments** be amended to delete the Airport from Transit/Airport as follows:

Monthly Charge - Transit \$80

5. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
