## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **RESOLUTION ADOPTING A REVISED FEE SCHEDULE FOR THE NEVADA COUNTY ANIMAL CONTROL PROGRAM PER GENERAL CODE SECTION IV 1.22 EFFECTIVE JANUARY 1, 2016**

WHEREAS, the General Code of the County of Nevada directs the Board of Supervisors to set the amount of fees for animal control services; and

WHEREAS, On June 21, 2005, Resolution 05-279 was adopted which established a fee schedule for the Nevada County Animal Control Program; and

WHEREAS, On July 8, 2014, Resolution 14-347 was adopted which established an increase in fees for dog licensing and related fees; and

WHEREAS, certain fees charged for providing services have not been updated since 2005; and

WHEREAS, the County of Nevada desires to increase fees to partially offset increased costs of these services, while accomplishing policy objectives; and

WHEREAS, the County of Nevada desires these fees to be fair and equitable to the recipients of such services and to the County taxpayers; and

WHEREAS, a duly noticed Public Hearing was held October 13, 2015.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors of the County of Nevada, State of California, approves and authorizes the revised Animal Control Fee Schedule included herein as Exhibit "A", which shall supersede and replace all other Resolutions pertaining to these Animal Control Fees, to become effective on January 1, 2016; and

BE IT FURTHER RESOLVED, while these fees shall be collected at all times, the Board of Supervisors authorizes waiver or reduction of these fees as needed by the Animal Shelter, to encourage adoption during times of overpopulation. The Shelter Manager shall maintain and provide documentation within twenty-four hours to the authorized representative at the Sheriff's Office to account for the shelter fees being waived or reduced; and

BE IT FURTHER RESOLVED that by adoption of this Resolution, Resolutions 05-279 and 14-347 are hereby rescinded.
