



# RESOLUTION NO. 17-217

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION APPROVING EXECUTION OF AMENDMENT A04 TO THE RENEWAL AGREEMENT NO. 14-10525 WITH THE CALIFORNIA DEPARTMENT OF PUBLIC HEALTH (CDPH) FOR PUBLIC HEALTH EMERGENCY PREPAREDNESS (PHEP), PANDEMIC INFLUENZA (PAN FLU), AND, HOSPITAL PREPAREDNESS PROGRAM (HPP) FUNDING (RESOLUTIONS 14-404; 15-164; 16-086; 16-525)

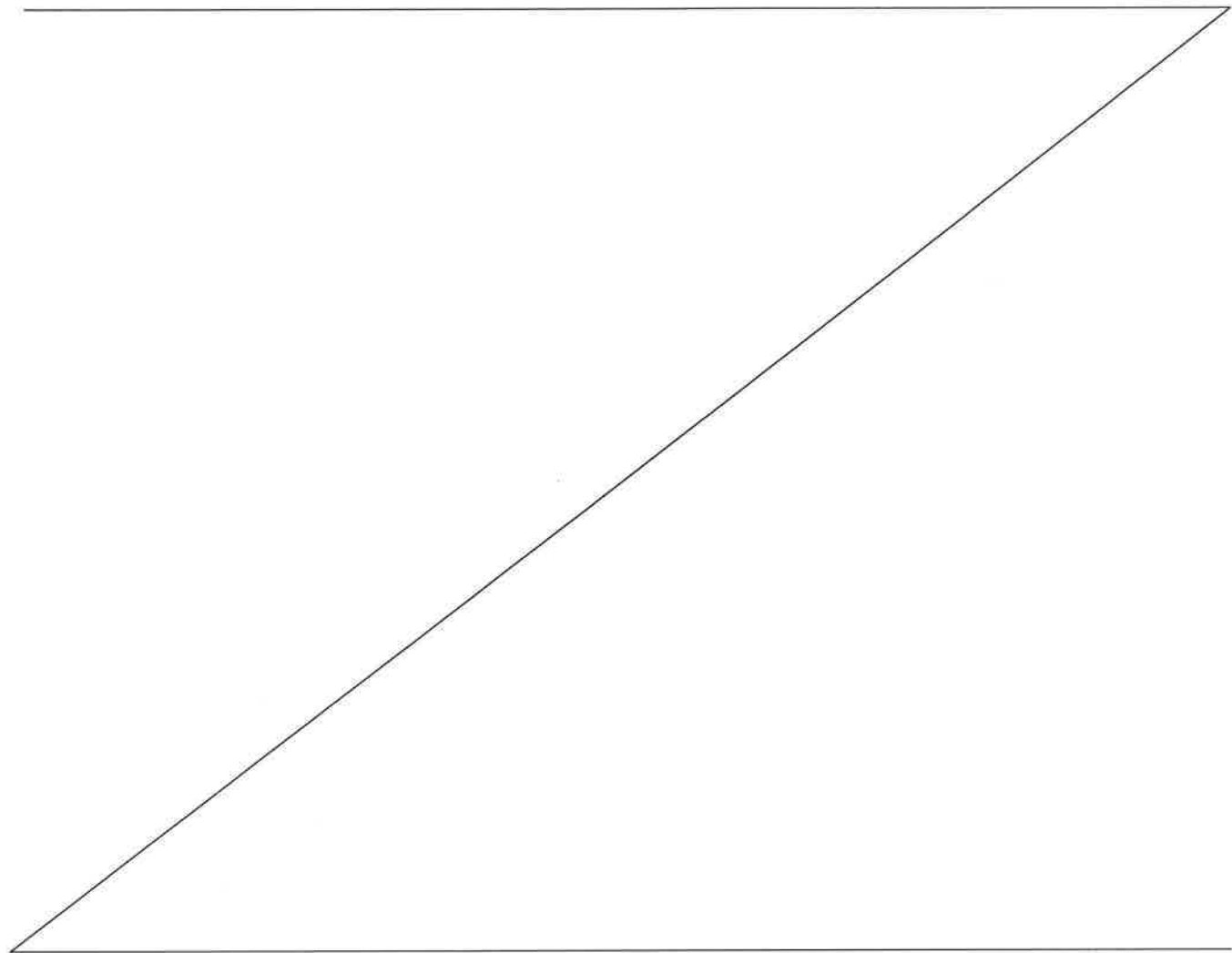
WHEREAS, the California Department of Public Health administers State and Federal funds for local emergency preparedness; and

WHEREAS, per Resolution 14-404, the Nevada County Board of Supervisors approved the State Agreement allocating the County funding for Emergency Preparedness (PHEP), Pandemic Influenza (Pan Flu) and the Hospital Preparedness Program (HPP) to be used to support the County's Work Plans and efforts to prepare and respond to public health emergency events and pandemic influenza and outbreaks of other infectious diseases; and subsequently approved Amendment A01 which increased the Agreement maximum from \$1,050,219 to \$1,108,202 per Resolution 15-164; Amendment A02 which decreased the Agreement maximum from \$1,108,202 to \$1,107,717 per Resolution 16-086; and Amendment A03 which decreased the Agreement maximum from \$1,107,717 to \$1,097,757 per Resolution 16-525; and

WHEREAS, the parties desire to amend the Agreement to increase the maximum amount payable and provide for a one-year extension.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment A04 to Agreement No. 14-10525 by and between the County and the California Department of Public Health pertaining to funding local Public Health Emergency Preparedness, Pandemic Influenza and the Hospital Preparedness Program to increase the maximum amount payable from \$1,097,757 to \$1,105,967 (an increase of \$8,210) and provide for a one-year extension for a revised term of July 1, 2014 through June 30, 2018, hereby is approved in substantially the same form attached hereto and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.

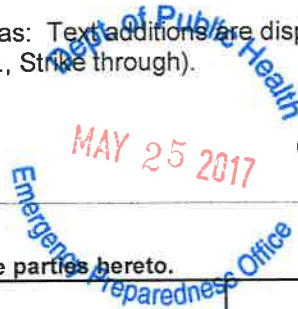

The one-year extension (July 1, 2017 to June 30, 2018) is contingent upon approval of the federal government, Office of the Assistant Secretary for Preparedness and Response (ASPR)/Hospital Preparedness Program (HPP) and the Centers for Disease Control and Prevention (CDC)/Public Health Emergency Preparedness (PHEP).
- II. Certain changes made in this amendment are shown as: Text additions are displayed in **bold and underline**. Text deletions are displayed as strike through text (i.e., ~~Strike through~~).

### HPP Capability 1: Healthcare System Preparedness

**Objective:** Strengthen the ability of a community’s healthcare system to prepare, respond, and recover from incidents that have a public health and medical impact in the short and long term. The healthcare system role in community preparedness involves coordination with emergency management, public health, mental/behavioral health providers, community and faith-based partners, state, local, and territorial governments to do the following: 1) Provide and sustain a tiered, scalable, and flexible approach to attain needed disaster response and recovery capabilities while not jeopardizing services to individuals in the community; 2) Provide timely monitoring and management of resources; 3) Coordinate the allocation of emergency medical care resources; and 4) Provide timely and relevant information on the status of the incident and healthcare system to key stakeholders. Healthcare system preparedness is achieved through a continuous cycle of planning, organizing and equipping, training, exercises, evaluations and corrective actions.

The focus is an effective and efficient return to normalcy or a new standard of normalcy for the provision of healthcare delivery to the community.

This is done through multi-agency coordination representing healthcare organizations or by integrating this coordination into plans and protocols that guide incident management to make the appropriate decisions. Coordination ensures that the healthcare organizations, incident management, and the public have relevant and timely information about the status and needs of the healthcare delivery system in the community. This enables healthcare organizations to coordinate their response with that of the community response and according to the framework of the National Incident Management System (NIMS).

Coordination also includes the proper and culturally sensitive storage of human remains during periods of increased deaths at healthcare organizations during an incident.

Out of State Travel: Supplies means: consumables office supply these are item that may be destroyed, dissipated, wasted are products that consumers buy recurrently i.e., items which "get used up" or discarded.

For example consumable office supplies are such products as paper, pens, file folder, binders, post-it notes, computer disks, and toner or ink cartridges, etc..

Note: Supplies do not include capital goods such as computers, fax machines, and other business machines or office furniture these would need to be set up in there own line item.

Note: Budget should link back to the SOW i.e. subcontractors/conferences/meeting/training/travel/printing/major equipment etc.... these types of services must be identified in the SOW (who/what/when and where)
