OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION TO AWARD A CONTRACT FOR THE NEWTOWN ROAD CLASS II BIKE LANE PROJECT, COUNTY CONTRACT NO. 229620, FEDERAL PROJECT NO. CMLL 5917 (070) – DISTRICT 1

WHEREAS, the Nevada County Board of Supervisors by Resolution 16-124 instructed the Clerk of the Board of Supervisors to advertise for bids Newtown Road Class II Bike Lane Project; and

WHEREAS, bids were opened on May 12, 2016, with the low bid being \$1,055,339.00; and

WHEREAS, construction is anticipated to begin in July and be completed within 50 working days, as allowed for in the contract; and

WHEREAS, this contract must be awarded on June 14, 2016 in order to meet bid to contract requirements, and the contract is subject to budget appropriations to be approved by the Board of Supervisors on June 21, 2016; and

WHEREAS, there are sufficient funds in the proposed Fiscal Year 2016/17 CIP budget code 1114-30154-702-1000/540711.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Awards the Contract to the low bidder, Baldwin Contracting, Inc., DBA Knife River Construction at the bid price of \$1,055,339, plus a 10 percent contingency for the contract work items, for a grand total of \$1,160,873.
2. Authorizes the Chair of the Board of Supervisors to execute on behalf of Nevada County a Public Works Contract between Nevada County and Baldwin Contracting, Inc., DBA Knife River Construction, upon receipt of the Labor and Materials Bond, Performance Bond and Certificate of Insurance by the Director of Public Works and approval and acceptance of the Certificate of Insurance by the Risk Manager.

THIS AGREEMENT, made and concluded, in duplicate, between the County of Nevada thereof, party of the first part, and **Baldwin Contracting, Inc., DBA Knife River Construction**, Contractor, party of the second part.

ARTICLE I.--WITNESSETH, That for and in consideration of the payments and agreements hereinafter mentioned, to be made and performed by the said party of the first part, and under the conditions expressed in the 2 bonds, bearing even date with these presents, and hereunto annexed, the said party of the second part agrees with the said party of the first part, at his own proper cost and expense, to do all the work and furnish all the materials, except such as are mentioned in the specifications to be furnished by said party of the first part, necessary to construct and complete in a good, workmanlike and substantial manner and to the satisfaction of the County of Nevada, the work described in the special provisions and the project plans described below, including any addenda thereto, and also in conformance with the California Department of Transportation Standard Plans, dated May 2006 the Standard Specifications, dated May 2006 and the Labor Surcharge and Equipment Rental Rates in effect on the date the work is accomplished, which said special provisions, project plans, Standard Plans, Standard Specifications, and Labor Surcharge and Equipment Rental Rates are hereby specially referred to and by such reference made a part hereof.

ARTICLE II.--The said party of the first part hereby promises and agrees with the said Contractor to employ, and does hereby employ, the said Contractor to provide the materials and to do the work according to the terms and conditions herein contained and referred to, for the prices hereinafter set forth, and hereby contracts to pay the same at the time, in the manner and upon the conditions herein set forth; and the said parties for themselves, their heirs, executors, administrators, successors and assigns, do hereby agree to the full performance of the covenants herein contained.

ARTICLE III.--The State general prevailing wage rates determined by the Director of Industrial Relations are hereby made a part of this contract. It is further expressly agreed by and between the parties hereto that should there be any conflict between the terms of this instrument and the bid or proposal of said Contractor, then this instrument shall control and nothing herein shall be considered as an acceptance of the said terms of said proposal conflicting herewith.

ARTICLE IV.--By my signature hereunder, as Contractor, I certify that I am aware of the provisions of Section 3700 of the Labor Code which require every employer to be insured against liability for worker's compensation or to undertake self insurance in conformance with the provisions of that code, and I will comply with such provisions before commencing the performance of the work of this contract.

ARTICLE V.--And the said Contractor agrees to receive and accept the following prices as full compensation for furnishing all materials and for doing all the work contemplated and embraced in this agreement; also for all loss or damage, arising out of the nature of the work aforesaid, or from the action of the elements, or from any unforeseen difficulties or obstructions which may arise or be encountered in the prosecution of the work until its acceptance by the NEVADA COUNTY DEPARTMENT OF PUBLIC WORKS, and for all risks of every description connected with the work; also for all expenses incurred by or in consequence of the suspension or discontinuance of work and for well and faithfully completing the work, and the whole thereof, in the manner and according to the plans and specifications, and the requirements of the Engineer under them, to wit:


