**BACKGROUND:**

At their meeting of June 5, 2018, the Fish and Wildlife Commission approved revised Bylaws reducing the commission membership from nine to five members, and additionally that each member of the Board of Supervisors appoint one member, from residents of the County at-large, with no more than two members being from any one supervisorial district. At the meeting of June 26, 2018, the Nevada County Board of Supervisors approved Resolution 18-304 amending the Nevada County Fish and Wildlife Commission Bylaws.

On July 17, 2018 Supervisor Dan Miller appointed Mr. Jeff Hollstien (who had been serving as a Member-at-Large) to be his District III representative and Supervisor Hank Weston appointed Mr. Jeff Jenkins (who had been serving as a Member-at-large) as his District IV representative.

Please acknowledge Supervisor Miller's appointment of Mr. Jeff Hollstien as his District III representative, and Supervisor Weston's appointment of Mr. Jeff Jenkins as his District IV representative on the Fish and Wildlife Commission.
