**SUBJECT:** Resolution amending Resolution 21-178 to designate the Nevada County Arts Council as Nevada County's ongoing local partner for the CAC State-Local Partnership Program, approves the submittal of ongoing annual applications by the Nevada County Arts Council to the CAC and designates the Nevada County Arts Council to execute CAC's grants as approved by the California Arts Council.

**BACKGROUND:** Since 2009, the Arts Collaborative of Nevada County, also referred to as the Nevada County Arts Council, has been the county-designated organization in the California Arts Council State-Local Partnership Program. The program provides operating and technical resources to the county designee with the purpose to foster cultural development on the local level on humanities and art. Support includes funding, information exchange, cooperative activities and leadership assistance. As the local designee, the Nevada County Arts Council assisted the cities of Grass Valley and Nevada City and the Town of Truckee of applying and becoming state designated cultural districts. The Board of Supervisors last designated the Nevada County Arts Council on an ongoing basis and directed the Arts Council and to submit biennial grants to the state as the county's local designee on March 25, 2021 via Resolution 21-178.

Since 2021, the state of California has amended its process to require the submittal of grant applications from CAC- Local-State Partners in congruence with the state's fiscal year instead of biennially. Therefore, the attached Resolution amends Resolution 21-178 to authorize Nevada County Arts Council to submit its grant applications annually instead of biennially and to administer and implement them as applicable. In addition, Nevada County Arts Council Executive Director Eliza Tudor will provide the Board with an overview presentation of their most recent work. Therefore, staff recommends the Board adopted the attached Resolution and receive an update presentation from the Nevada County Arts Council.
