OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 1 TO THE CONTRACT BETWEEN THE COUNTY OF NEVADA AND AVFUEL CORPORATION, TO INCLUDE THE AIRPORT'S PARTICIPATION IN THE CONTRACT FUEL DEALER PROGRAM TO THE AGREEMENT

WHEREAS, on February 26th, 2019, per Resolution 19-084 the Nevada County Board of Supervisors approved a contract with Avfuel Corporation for aviation fuel and support services at the Nevada County Airport for a contract term of March 1, 2019 to June 30, 2024; and

WHEREAS, the original contract included the terms and conditions of the Contract Fuel Dealer Program however we opted not to initially sign up for participation. Since inception of the Avfuel contract we have analyzed the benefits for customers and Nevada County Airport; and

WHEREAS, the both parties desire to amend the contract to include the Nevada County Airport participation in the contract fuel dealer program as outlined in the original contract.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Nevada, State of California, approves Amendment No. 1 by and between the County of Nevada and Avfuel Corporation pertaining to aviation fuel services and support at the Nevada County Airport for the period of March 1, 2019 through June 30, 2024 to include participation in the Contract Fuel Dealer Program and authorizes the Chair of the Board of Supervisors to execute amendment one to the contract.

THIS AMENDMENT is executed this 28th day of April, 2020 by and between Avfuel Corporation, hereinafter referred to as "Contractor," and COUNTY OF NEVADA, hereinafter referred to as "County," (collectively, the "Parties"). Said Amendment will amend the prior agreement between the parties entitled Aviation Fuel Services and Support executed on March 1, 2019 by Resolution 19-084

WHEREAS, the contract did not include the contract fuel dealer program, which offers benefits for customers and Nevada County Airport.

WHEREAS, the parties desire to amend the contract to add Nevada County Airport in the Contract Fuel Dealer Program; and

NOW, THEREFORE, the parties hereto agree as follows:

1. That this amendment shall be effective as of 28 April 2020.
2. That the Schedule of Services, Exhibit "A" is amended by adding the following: Participation in the Contract Fuel Dealer Program
3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.
