On page 352 of the **minutes of March 12, 1974** a Committee was established for the purpose of determining the priorities for the local grant monies.

On page 817 of the **minutes of January 18, 1982** there was a motion to implement a ballot measure to establish a recreation district in Western Nevada County.

On page 915 of the **minutes of February 8, 1982** there is a Sub-Committee Report on Recreation.

On page 1060 of the **minutes of March 22, 1982** the Board of Supervisors adopted **Resolution 82-068**, Motion of Intention to Form a Recreation and Park District for Western Nevada County.

On page 2270 of the **minutes of June 14, 1982** there is discussion regarding the Western Gateway Park and Ballot Measure.

On page 2313 of the **minutes of June 28, 1982** the Board of Supervisors adopted **Resolution 82-194** Calling for an Election regarding the Western Nevada County Recreation and Park District.

On page 2 of the **minutes of July 6, 1982** the Board of Supervisors adopted **Resolution 82-207** consolidating the Election.

On page 5 of the **minutes of July 6, 1982** the Board of Supervisors adopted the ballot wording for the Western Nevada County Recreation and Park District.

On page 68 of the **minutes of July 19, 1982** the Board of Supervisors adopted **Resolution 82-233** amending Resolution 82-194 calling for an Election on the formation of a Recreation and Park District.

On page 690 of the **minutes of November 29, 1982** the Board of Supervisors adopted **Resolution 82-396** adopting the Certified Statement of the Election. Measure A Defeated.

On page 1243 of the **minutes of February 2, 1987** there was a recommendation to the Board of Supervisors to place the creation of Community Service Area for Recreation on the November 1987 Ballot.

On page 1415 of the **minutes of March 23, 1987** there was a request for approval regarding the Community Service Area for Recreation.

On page 1415 of the **minutes of March 23, 1987** there was discussion regarding Fees for LAFCo for the Community Service Area.

On page 1433 of the **minutes of March 24, 1987** the Board of Supervisors adopted **Resolution 87-109** requesting LAFCo approval.

On page 1495 of the **minutes of April 13, 1987** funds were approved for the County Recreation Plan.

On page 212 of the **minutes of August 4, 1987** there was discussion regarding the Community Service Area and **Resolutions 87-339** (Intention to provide service) and **87-340** (Intention to annex into Community Service Area) were adopted. **Resolution 87-338** calling for the Ballot Measure was also adopted.

On page 249 of the **minutes of August 11, 1987** there was discussion regarding the Administration of the Recreation Development Fees and **Resolution 87-361** regarding Administration of Recreation Development Fees was adopted.

On page 458 of the **minutes of September 15, 1987** there was discussion regarding services and annexation.

On pages 459 and 460 of the **minutes of September 15, 1987** there was discussion regarding services and annexation. **Resolution 87-418** amending **Resolution 87-339** and **Resolution 87-419** amending **Resolution 87-340** were adopted.

On page 554 of the **minutes of October 13, 1987** there was a request to hold a Special Hearing for the Adoption of the Recreation Plan.

On page 602 of the **minutes of October 20, 1987** there was a Public Hearing to Consider Annexation.

On page 603 of the **minutes of October 20, 1987** there was a Public Hearing to Consider the Extension of Services.

On page 606 of the **minutes of October 20, 1987** there was discussion regarding the Intention to Appoint a Recreation Commission.

On page 647 of the **minutes of October 29, 1987** there was a Public Hearing to Consider the Adoption of the Recreation Plan. **Resolution 87-493** was adopted.

On page 649 of the **minutes of October 29, 1987** there was discussion regarding a Joint Powers Agreement with Nevada City and **Resolution 87-494** was adopted.

On page 650 of the **minutes of October 29, 1987** there was discussion and **Resolution 87-495** of Intention to Appoint a Recreation Commission was adopted.

On page 732 of the **minutes of November 17, 1987** there was direction to Staff regarding a Parks and Recreation Task Force.

On page 760 of the **minutes of December 1, 1987** there was discussion and **Resolution 87-533** was adopted. Measure B Failed.

On page 811 of the **minutes of December 15, 1987** there was an appointment to the Recreation Committee.

On page 1137 of the **minutes of March 8, 1988** there was a recommendation by the Recreation Committee and a Motion of Intent to Implement a County Parks and Recreation Program.

On page 207 of the **minutes of August 30, 1988** there was discussion and **Resolution 88-460** establishing the Nevada County Recreation Commission was adopted. **Resolution 88-461** rescinding the Nevada County Parks and Recreation Committee was adopted.

On page 244 of the **minutes of September 6, 1988** there was discussion and **Ordinance 1521** Revising the Appointment and Powers and Duties of the Recreation Committee was adopted.

On page 245 of the **minutes of September 6, 1988** there was a Motion of Intent to accept the Recreation Task Force Findings and Recommendations.

On page 365 of the **minutes of October 11, 1988** there was discussion and **Ordinance 1533** regarding the Powers and Duties of the Recreation Commission was adopted.

On page 545 of the **minutes of December 20, 1988** there was discussion regarding fees and **Resolution 88-658** was adopted regarding the collection of fees.

On page 572 of the **minutes of January 3, 1989** appointments were made to the Recreation Commission. There was discussion regarding the method of appointment.

On page 678 of the **minutes of February 14, 1989** there was discussion and **Ordinance 1559** was adopted regarding the appointment of members to the Recreation Commission.

On page 354 of **the minutes of November 3, 1998** there was discussion regarding the Recreation Commission formed by **Resolution 88-460** and the first reading of an Ordinance.

On page 488 of the **minutes of December 15, 1998** the Board of Supervisors adopted **Ordinance 1989** Repealing Article 9 of Chapter II of the Administrative Code regarding the Recreation Commission.

On page 488 of the **minutes of December 15, 1998** there was discussion regarding the formation of two new Recreation Districts. **Resolution 98-553** was adopted forming the Ad Hoc Recreation Advisory Committee.

On page 512 of the **minutes of February 27, 2001** the Board of Supervisors adopted **Resolution 01-067** dissolving the Ad Hoc Recreation Advisory Committee.
