

**NEVADA COUNTY BOARD OF SUPERVISORS
IS SEEKING INTERESTED PERSONS TO SERVE ON THE FOLLOWING:**

***ADULT AND FAMILY SERVICES COMMISSION:** (5 vacancies) Two Public Sector vacancies, one to fill a 2-year unexpired term ending April 30, 2021 and the other to fill a 2-year unexpired term ending April 30, 2022; three Private Sector vacancies; one to fill a 2-year unexpired term ending April 30, 2021; and two for 2-year terms ending April 30, 2022. This Commission shall operate under the Nevada County Board of Supervisors as the primary advisory body relative to health and human service's needs and performs the responsibilities of the Board of Directors as described under Title 42 USC Chapter 106 § 9910 - Tripartite Boards. Private Sector members shall represent labor, business, or other private business, industry, labor, religious, human services, education, or other major groups and interests in the community. ***AGRICULTURAL ADVISORY COMMISSION:** (2 positions) Any two of the following vacant positions; Viticulture Industry representative to fill a 4-yr. unexpired term ending March 1, 2024, Equine Industry representative to fill a 4-yr unexpired term ending March 1, 2022 or a Forest & Related Industry representative to fill a 4-yr unexpired term ending March 1, 2023. The Commission shall advise the Board of Supervisors on matters concerning the agricultural resources of the County, develop a framework for cooperation among agencies and institutions, interest groups, individuals, public and private property owner, and all others for wise conservation and management of resources to benefit the County's agricultural assets, and maintain an active Agricultural Commission to advise the County on agricultural-related matters. ***ASSESSMENT APPEALS BOARD:** (2 vacancies) Two alternate members to fill unexpired 1-year terms ending September 30, 2021. Specific qualifications are required per Section 1624 of the Revenue and Taxation Code. The function of the Appeals Board is to determine the full value of property or to determine other matters of property tax assessment over which the Appeals Board has jurisdiction. The Board acts in a quasi-judicial capacity and renders its decision only on the basis of proper evidence presented at the hearing. Said group members may not be employees of the County of Nevada. Each group member will be qualified by experience and training to pass on matters pertaining to sewage disposal. The purpose will be to review and recommend proposed revisions and additions to the sewage disposal regulations or sewage disposal ordinance in an advisory capacity; review and recommend new methods, techniques, and materials for on-site sewage disposal, in an advisory capacity; and serve as an appeal body under the provisions of Section A-032 of County Resolution 98-217.
