RESOLUTION SEEKING MEMBERSHIP IN THE AARP AGE-FRIENDLY NETWORK AND AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO SIGN THE LETTER OF SUPPORT FOR MEMBERSHIP ON BEHALF OF THE COUNTY OF NEVADA


