OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING A CONTRACT WITH GMV SYNCROMATICS CORP (GMV) FOR THE PURCHASE AND INSTALLATION OF COMPUTER AIDED DISPATCHING, SCHEDULING AND HARDWARE FOR FIXED ROUTE TRANSIT SERVICES FOR A BASE PERIOD OF THREE (3) YEARS IN AN AMOUNT NOT TO EXCEED \$205,996 AND AUTHORIZING THE CHAIR OF THE BOARD TO EXECUTE THE CONTRACT (DISTRICTS I-IV)

WHEREAS, on July 10, 2023, the Governor of California approved SB125 which directed the California State Transportation Agency (CalSTA) to disburse up to \$5.1 Billion in capital and operating funds to state transit agencies via the Transit and Intercity Rail Capital Program (TIRCP) \$4 billion, and the Zero-Emission Transit Capital Program (ZETCP) \$1.1 billion; and

WHEREAS, on July 8, 2024, NCTC was awarded an initial disbursement of \$1,486,685 of TIRCP funds and \$431,222 of ZETCP funds for Nevada County Connects projects, including the purchase of fixed route and paratransit dispatching and scheduling software and hardware; and

WHEREAS, the County released Request for Proposals No. 204232 on August 25, 2025, for Computer Aided Dispatching, Scheduling and Hardware for Fixed-Route Services and Demand Response Paratransit Services, Including a Mobile Application for Demand Response; and

WHEREAS, a total of nine eligible proposals were received specific to the Fixed Route services; and

WHEREAS, the proposal evaluation team consisting of internal staff and external industry peers evaluated the proposals based on established criteria with the top three scoring proposers being invited to oral interviews; and

WHEREAS, GMV Syncromatics Corp (GMV) were selected as the proposer providing the most responsive, reasonable and best value for Category A Fixed Route Services; and

WHEREAS, the proposed contract is for a base term of three years, July 1, 2026 through June 30, 2029, and includes the purchase and installation of all required hardware and software in addition to staff training; and

WHEREAS, the County and GMV staff will schedule, prepare and participate in a Project Kick-off meeting that will result in a comprehensive Project Implementation Work Plan and deliverables schedule; and

WHEREAS, the Transit Services Division has sufficient funding available in SB125 Transit and Intercity Rail Capital Program (TIRCP) funds account FD4281 CC91003 PG7073100 PRJ000012 GR0000031; and

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Approves the attached Contract with GMV Syncromatics Corp for the Purchase and Installation of Computer Aided Dispatching, Scheduling and Hardware for Fixed Route Services (Category A) for a base term of three-years in an amount not to exceed \$205,996.
2. Authorizes the Chair of the Board to execute the contract with GMV Syncromatics Corp (GMV) in an amount not to exceed \$205,996.
