OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION TO AMEND RESOLUTION 18-368 AUTHORIZING THE SUBMITTAL OF AN APPLICATION TO THE CALIFORNIA STATE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT (HCD) FOR FUNDING UNDER THE HOME INVESTMENT PARTNERSHIPS PROGRAM IN THE AMOUNT OF \$1,000,000; AND IF SELECTED, THE EXECUTION OF A STANDARD AGREEMENT, ANY AMENDMENTS THERETO, AND OF ANY RELATED DOCUMENTS NECESSARY TO PARTICIPATE IN THE HOME INVESTMENT PARTNERSHIPS PROGRAM

WHEREAS, the Nevada County Board of Supervisors authorized the submittal of the 2018 HOME Investment Partnerships Program application and subsequent execution, July 17, 2018, per Resolution 18-368; and

WHEREAS, the HOME Investment Partnerships Program Standard Agreement 18-HOME-12592 was scheduled to be disencumbered as of February 2, 2023; and

WHEREAS, the California State Department of Community Development (HCD) has agreed to approve the Health and Human Services Agency's Housing and Community Services Division request to extend the Standard Agreement for an additional 15 months; and

WHEREAS, a review of Resolution 18-368 found items number 3 and 4 required amending prior to the execution of the grant extension.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors authorizes the following amendments to Resolution 18-368:

3. The County of Nevada authorizes the Chair of the Board of Supervisors or the Director of the Nevada County Health and Human Services Agency, to sign and submit this application for HOME Investment Partnerships Program funds and act in all matters pertaining to this application on behalf of Nevada County. If the application is approved, the Nevada County Board of Supervisors, authorizes the Chair of the Board or the Director of the Nevada County Health and Human Services Agency to enter into and sign the grant agreement and any subsequent amendments with the State of California for the purposes of this grant.
4. If the application is approved, the Nevada County Board of Supervisors authorizes the Health and Human Services Agency Director or the Director of Child Support Services/Collections and Housing & Community Services, to sign all other subsequent documents required by the HOME Program, including, Funds Requests and other required reporting forms.
