### **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

**RESOLUTION APPROVING AMENDMENT NO. 1 TO AGREEMENT BETWEEN THE COUNTY OF NEVADA AND THOMSON REUTERS' WEST PUBLISHING CORPORATION REGARDING ON-LINE LEGAL RESEARCH, LEGAL CALENDARING AND LEGAL DOCUMENT PREPARATION SOFTWARE, AND RELATED SERVICES, INCREASING THE MAXIMUM CONTRACT PRICE BY \$5,937.13, FOR A TOTAL MAXIMUM CONTRACT PRICE OF \$39,128.57, AND AUTHORIZING THE CHAIR OF THE BOARD TO EXECUTE THE AMENDMENT**

WHEREAS, the Office of the County Counsel serves as in-house counsel and provides a wide array of legal services for the County of Nevada, including litigation services; and

WHEREAS, online legal research, calendaring and other technology-based support services are the most cost-effective and efficient way to maintain the resources necessary to operate and manage in-house legal services and ensure that the office remains current on legal issues; and

WHEREAS, the parties entered into an agreement with Thomson Reuters for legal research and other support services, for the period of July 1, 2016 through June 30, 2019, Resolution 16-286; and

WHEREAS, the parties entered into a renewal agreement with Thomson Reuters for legal research and other support services, for a new three-year term commencing July 1, 2019, Resolution 19-285 (BMS19285) with a termination date of June 30, 2022; and

WHEREAS, Thomson Reuters offers two add-on products, Drafting Assistant and Practical Law, to the West Proflex software. These services will provide the tools needed to provide for more efficient drafting of legal pleadings and enable more specific and on-point research related to litigation briefs; and

WHEREAS, Contractor is willing to provide these added tools immediately upon execution of this Agreement at no additional charge for the remainder of this current fiscal year 2019-20; and

WHEREAS, Thomson Reuters is a leading provider of legal publications, online research services, case management and calendaring programs and other legal support services and is willing and well qualified to provide such services to the County.

NOW, THEREFORE, BE IT RESOLVED that Amendment No. 1 to the Agreement by and between the County of Nevada and Thomson Reuters' West Publishing Corporation for West Proflex on-line legal research, legal calendaring, and legal document preparation software is hereby amended to increase the Maximum Contract Price for the period of July 1, 2019 through June 30, 2022 by \$5,937.13, for a total Maximum Contract Price of \$39,128.57 (increasing Fiscal Year 2019-20 by \$0 for a maximum \$10,738.44, increasing Fiscal Year 2020-21 by \$2,993.93 for a maximum \$14,054.52, and increasing Fiscal Year 2021-22 by \$2,943.20 for a maximum \$14,335.61) be and hereby is approved in the form attached hereto and that the Chair of the Board of Supervisors is hereby authorized to execute the Agreement.
