



ORDINANCE No. 2445

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

ORDINANCE REPEALING SECTION G-IV 3.A.25 OF ARTICLE 3.A OF CHAPTER IV OF THE NEVADA COUNTY GENERAL CODE PERTAINING TO TEN MINUTE PARKING AT THE LAKE WILDWOOD CLUBHOUSE

THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

SECTION I:

That the repeal of a ten-minute parking zone at the Lake Wildwood Clubhouse be approved based on the following findings A-B:

A. That the Lake Wildwood Clubhouse referenced in General Code Section G-IV 3.A.25 was demolished and a new clubhouse was constructed to replace it that does not have the same parking restrictions as the previous clubhouse, and that General Code Section G-IV 3.A.25 is therefore no longer applicable; and

B. That the Lake Wildwood Homeowners Association has requested the repeal of the ordinance.

SECTION II:

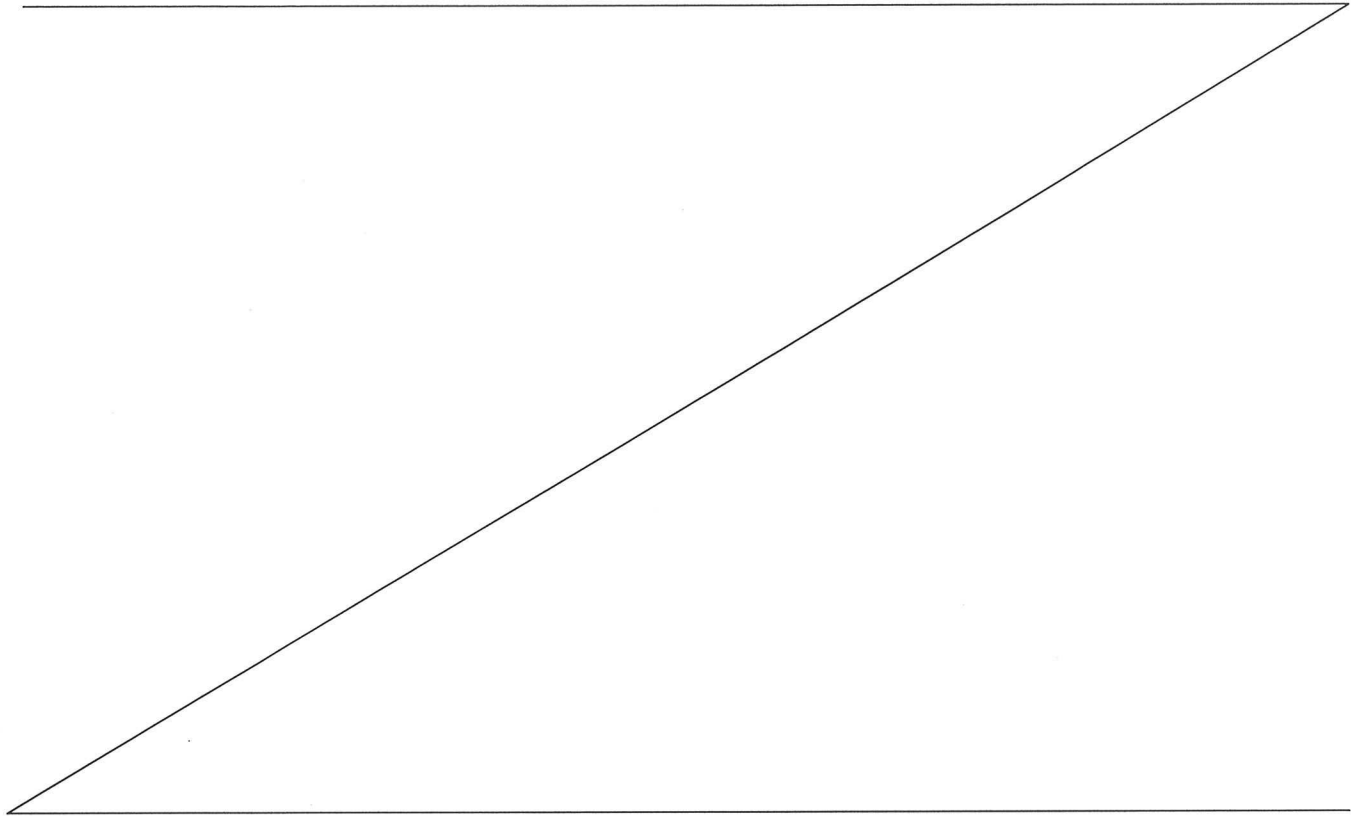
Section G-IV 3.A.25, of Article 3.A of Chapter IV of the Nevada County General Code is hereby repealed.

SECTION III:

If any section, sentence, clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional by a decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance. The Board of Supervisors hereby declares that it would have passed this ordinance and adopted this ordinance and each section, sentence, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared invalid or unconstitutional.

SECTION IV:

This Ordinance shall take effect and be in full force thirty (30) days from and after introduction and adoption, and it shall become operative on the 11th day of January, 2018, and before the expiration of fifteen (15) days after its passage it shall be published once, with the names of the Supervisors voting for and against same in the Union, a newspaper of general circulation printed and published in the County of Nevada.
