OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION REJECTING ALL BIDS RECEIVED FOR INVITATION FOR BID NO. 127248, APPROVING A STANDARD PUBLIC WORKS CONTRACT IN RESPONSE TO RE-BID NO 129440 BETWEEN THE COUNTY OF NEVADA AND EXTREME ROOFING FOR THE NEVADA COUNTY ROOF RESTORATION AND REPLACEMENT PROJECT AT VARIOUS LOCATIONS 2020 FOR COMPOSITE ROOF REPLACEMENT AT THE BOST HOUSE IN THE AMOUNT OF \$59,300 PLUS A CONTINGENCY OF \$5,930 FOR A TOTAL CONTRACT AMOUNT OF \$65,230, AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE CONTRACT, AND AMENDING THE FISCAL YEAR 2020-2021 CAPITAL FACILITIES AND BEHAVIORAL HEALTH BUDGETS (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, construction documents were prepared and approved through Resolution 20-119 for the project known as the Nevada County Roof Restoration and Replacement Project at Various Locations 2020; and

WHEREAS, the various locations include the Grass Valley Library, Bost House, Nevada City Courthouse, Madelyn Helling Library and the Truckee Government Center; and

WHEREAS, Invitation to Bid No. 127248 was solicited in accordance with the Public Contract Code and the Purchasing Policy and it was determined to be in the best interest of the County to reject all bids and re-solicit at a later date; and

WHEREAS, an Invitation to Re-Bid No. 129440 was solicited in accordance with the Public Contract Code and the Purchasing Policy that included a bid for installing a metal roof and a bid alternate for composition roofing on the Bost House on June 11, 2020; and

WHEREAS, eight timely bids were received and opened on June 23, 2020, and the lowest bid for the installation of a Composite Roof was from Extreme Roofing of Grass Valley, California, in the amount of \$59,300; and

WHEREAS, the contract will be in the bid amount of \$59,300 plus a 10% contingency of \$5,930 for a maximum contract amount of \$65,230; and

WHEREAS, funding for this project will be paid out of the Fiscal Year 2020-21 Capital Facilities budget and reimbursed by Behavioral Health using Community Based Transitional Housing grant funds.

NOW, THEREFORE, BE IT RESOLVED that the Nevada County Board of Supervisors hereby directs that:

1. The contract for the Nevada County Roof Restoration and Replacement Project at Various Locations 2020 for Composite Roof Replacement at the Bost House, 145 Bost Avenue, Nevada City, California, in the amount of \$59,300 plus a contingency of \$5,930 for a total contract amount of \$65,230 be awarded to Extreme Roofing, 16221 Rattlesnake Road, Grass Valley, California, 95945.
2. The Board approves and the Board Chair is authorized to execute a Nevada County standard public works contract on behalf of Nevada County with Extreme Roofing upon receipt, approval, and acceptance of the certificates of insurance and bonds.
3. The Purchasing Agent is authorized to execute change orders pursuant to Article IX of the Contract, up to the total contingency amount of \$5,930.
4. Contractor shall commence the work 10 days after mailing of written notice to proceed by County. All work shall be completed and ready for acceptance on or before 360 days of the mailing of the Notice to Proceed.
5. The Auditor-Controller is directed to amend the Fiscal Year 2020-21 Capital Facilities and Behavioral Health budgets as follows:
