## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

### RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. 1 TO THE CONTRACT WITH COMMON GOALS FOR THE PROVISION OF OUTPATIENT REHABILITATIVE TREATMENT SERVICES FOR THE RECOVERY AND TREATMENT OF SUBSTANCE USE DISORDERS TO REQUEST A CONTRACT ASSIGNMENT TO NEWLY FORMED NONPROFIT COMMON PURPOSE IN THE MAXIMUM AMOUNT OF \$1,551,983 FOR FISCAL YEAR 2023/24 (RES 23-365)

WHEREAS, the Contractor provides education and treatment services for persons affected by substance use disorders; and

WHEREAS, on July 11, 2023, per Resolution 23-365, the Nevada County Board of Supervisors approved execution of the Professional Services Contract with Common Goals to offer outpatient individual and group rehabilitation services in the community. Additionally, Contractor provides a new outpatient treatment program called the Recovery Incentives program; and

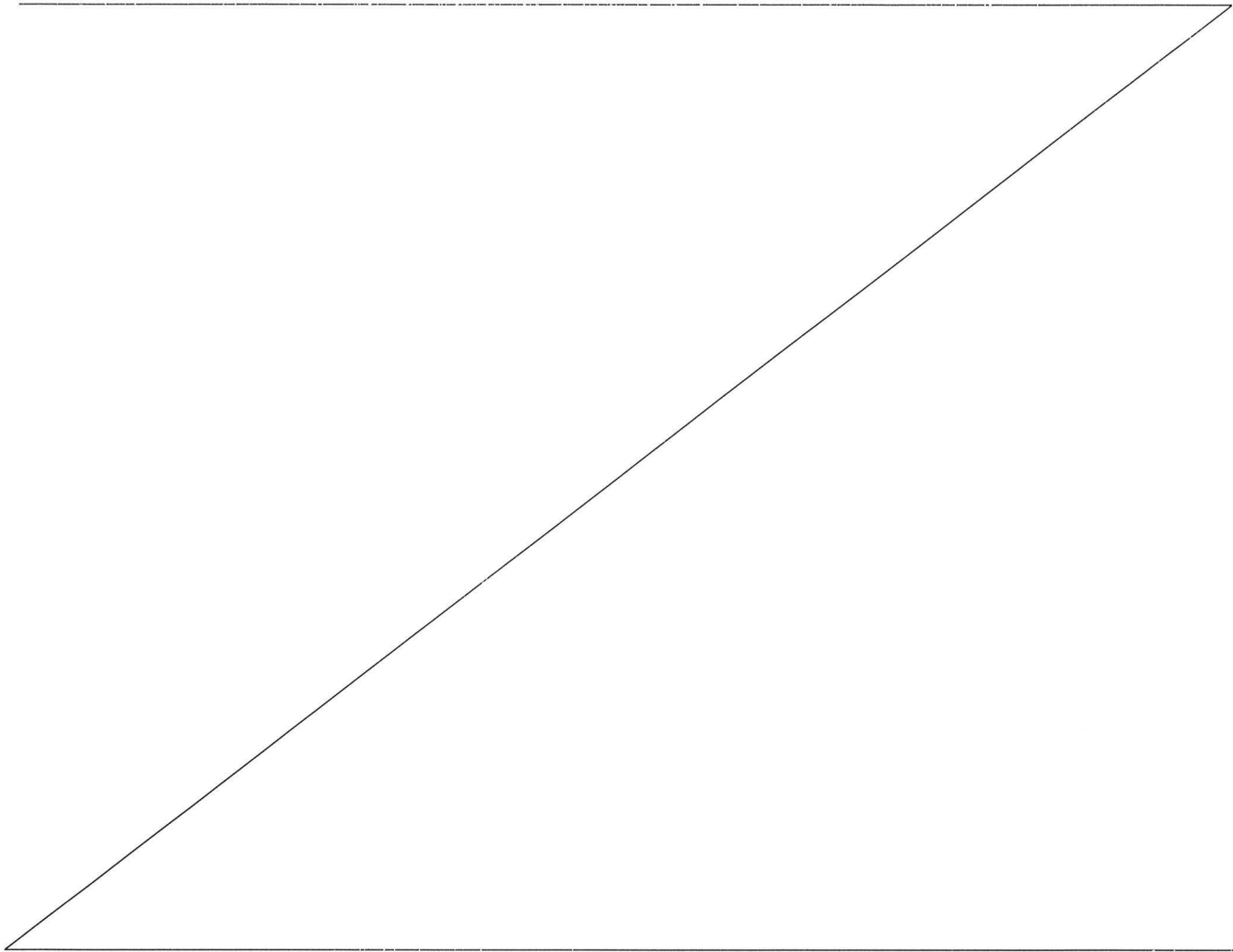
WHEREAS, by transitioning to a non-profit, the agency will become eligible to utilize additional funding sources through Behavioral Health, that are only able to be utilized by non-profit organizations; and

WHEREAS, with Common Goals fully converted to their Common Purpose non-profit, the County will be able to use Substance Use Block Grant funds to cover Outpatient Drug Free services, which are provided for individuals who we are unable to bill Drug Medi-Cal; and

WHEREAS, the parties desire to amend their Agreement to request an update to the Contractor name reflected in the Professional Services Contract as a result of the newly formed nonprofit.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Amendment to the Professional Services Contract by and between County and Common Purpose, Inc. pertaining to the provision of outpatient rehabilitative treatment services for the recovery and treatment of substance use disorders for the contract term of July 1, 2023, through June 30, 2024, in the maximum amount of \$1,551,983 be and hereby is approved, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.

**AMENDMENT #1 TO THE CONTRACT WITH  
COMMON GOALS (RES 23-365)**

**THIS AMENDMENT** is executed this February 27, 2024 by and between COMMON GOALS, hereinafter referred to as “Contractor” and COUNTY OF NEVADA, hereinafter referred to as “County.” Said Amendment will amend the prior Agreement between the parties entitled Professional Services Contract, executed on July 11, 2023 per Resolution 23-365; and

**WHEREAS**, the Contractor operates outpatient rehabilitative treatment services for Medi-Cal beneficiaries for the recovery and treatment of alcohol/drug dependency; and

**WHEREAS**, Common Goals has formed a nonprofit organization called ‘Common Purpose’ to continue to provide its services; and

**WHEREAS**, Common Goals has provided a Request for Contract Assignment assigning Common Purpose as the new contractor; and

**WHEREAS**, the parties desire to amend their Agreement to request an update to the Contractor name reflected in the Professional Services Contract from Common Goals to Common Purpose.

**NOW, THEREFORE**, the parties hereto agree as follows:

1. That Amendment #1 shall be effective as of 02/01/2024.
2. That the Contractor name shall be updated to reflect the Contractor name change Common Purpose.
3. That in all other respects the prior agreement of the parties shall remain in full force and effect except as amended herein.

Failure to comply may result in cancellation of the agreement. **Assignee** also agrees that this assignment entitles the County of Nevada to performance by **Assignee** of all obligations under the contract without modification, and that failure to perform as prescribed in the agreement constitutes grounds for immediate cancellation of the agreement.

The **Assignee** agrees that any payments made by the County of Nevada pursuant to the contract, including all payments assigned to the **Assignee**, shall be contingent upon the performance of the **Assignee** in accordance with all terms and conditions, requirements and specifications of the contract, and the approval and acceptance of such performance by the County of Nevada.

**Assignee** also agrees to provide relevant business information to the County of Nevada upon request, such as tax identification numbers, names of officers, references, etc., in order for the County to evaluate the capabilities of the **Assignee** in consideration of this Request for Assignment.
