### RESOLUTION ACCEPTING AWARD OF FISCAL YEAR 2014/15 PROPOSITION 1B (PROP 1B), PUBLIC TRANSPORTATION MODERNIZATION, IMPROVEMENT, AND SERVICE ENHANCEMENT ACCOUNT (PTMISEA) FUNDING ADMINISTERED BY THE CALIFORNIA DEPARTMENT OF TRANSPORTATION IN THE TOTAL AMOUNT OF \$527,986

WHEREAS, the Board of Supervisors adopted Resolutions 15-475 and 15-476 on October 13, 2015, approving the submittal of an applications for total Proposition 1B, PTMISEA funds of \$527,986 for bus stop improvements (\$127,986) and transit vehicle replacements (\$400,000) used by Gold Country Stage; and

WHEREAS, the application was submitted and an approved Caltrans project award letter, dated May 25, 2016, has been received by Transit Service.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors accepts the award for the Prop 1B, PTMISEA grant program funding in the total amount of \$527,986, deposited to Transit Services
