TO: Secretaries of Nevada County Special Districts holding elections November 3, 2020  
RE: District Elections to be held November 3, 2020

Elections Code Section 10509 requires that by **July 1, 2020** the district secretary shall send an official notice calling an election to the County Elections Office. The notice must bear the secretary's signature and the district seal, and include the following:

- A Resolution and Notification listing elective offices of the district to be filled at the general district election, their terms, whether the district or the candidate is to pay for the candidate's statement which appears in the Voter Information Guide and the word limit of any Statement of Qualifications.
- A map showing the boundaries of the district and the boundaries of the divisions of the district, if any, and a statement indicating in which divisions a director is to be elected. If no boundary changes have been implemented since November 2018, please include a statement to that effect in your district's "Notice of Election".
- A \$50.00 check made payable to "Nevada County Clerk" to cover the cost of publication of the election.

A sample of the Resolution Calling General District Election, Notice of District Election and Statement of Facts are enclosed for your convenience.

BE IT FURTHER RESOLVED THAT the Western Gateway Recreation & Park District agrees to reimburse the County of Nevada for the district's prorated share of the costs of the election.

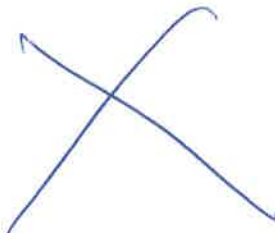
The County Clerk is authorized to administer the oath or affirmation which is incorporated in the nomination documents as required by Elections Code Section 10512.

- Boundary changes implemented since November 2018 are shown on the enclosed map.

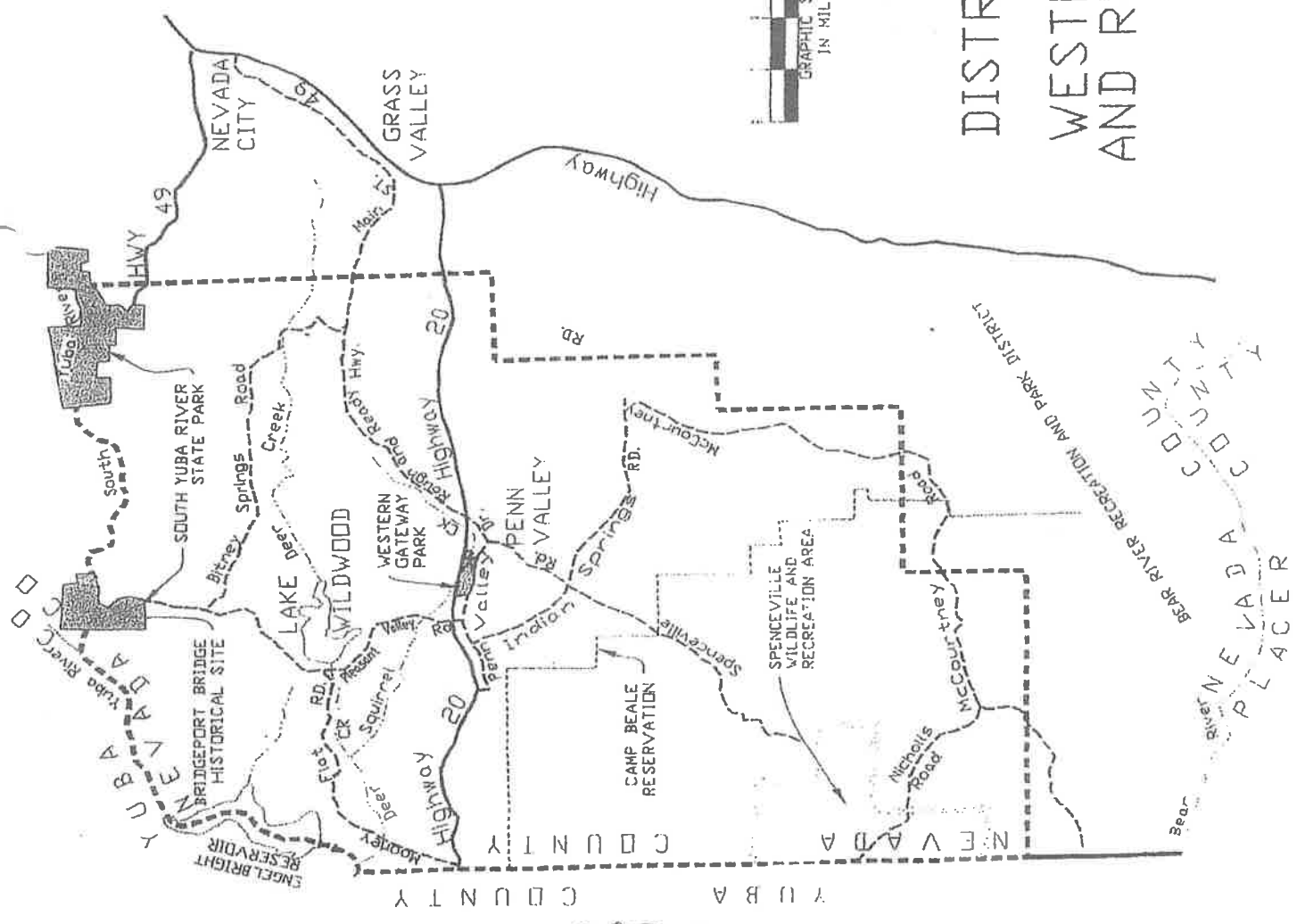
