OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AMENDMENT NO. 2 TO THE PROFESSIONAL SERVICES CONTRACT BETWEEN THE COUNTY OF NEVADA AND OPPENHEIMER INVESTIGATIONS GROUP, INCREASING THE CONTRACT AMOUNT BY \$35,000 FOR A MAXIMUM CONTRACT PRICE OF \$150,000 AND AUTHORIZING THE NEVADA COUNTY PURCHASING AGENT TO EXECUTE THE AMENDMENT AND ENCUMBER THE FUNDS

WHEREAS, Oppenheimer Investigations Group specializes in workplace investigations, and continues to contract with the County of Nevada for such services; and

WHEREAS, effective June 16, 2025, the County executed a Professional Services Contract ("Contract") with Oppenheimer Investigations Group in the amount of \$50,000 with a termination date of June 30, 2026 (PEST5182), to provide the County with investigation services; and


WHEREAS, on-going investigation services will require additional time to complete, more than contemplated in the original contract's scope of work; and

WHEREAS, the parties now desire to increase the maximum contract price of the Contract to \$150,000 (an increase of \$35,000); and

WHEREAS, services provided under this Agreement are paid on an as needed basis. The cost of this Agreement, although managed by the Human Resources Department, is billed directly to the respective department's budget utilizing the service, which has sufficient funding to cover this increase. There is no effect to the General Fund.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada that Amendment No. 2 to Professional Services Contract PEST5182, by and between the County of Nevada and Oppenheimer Investigations Group, increasing the maximum contract price to the new not to exceed amount of \$150,000, is hereby approved in the form attached hereto, and the Nevada County Purchasing Agent is hereby authorized to execute the Amendment and encumber the funds as follows:

**AMENDMENT #2 TO CONTRACT NO. PEST5182
