



# **ORDINANCE No.**

## **OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA**

### **AN ORDINANCE AMENDING SECTION G-IV 3.A.8 OF ARTICLE 3.A OF CHAPTER IV OF THE NEVADA COUNTY GENERAL CODE PERTAINING TO PARKING PROHIBITIONS – DISTRICTS 1, 2, 4 AND 5**

THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA, STATE OF CALIFORNIA, ORDAINS AS FOLLOWS:

#### SECTION I:

That the Amendment of parking prohibitions on Dog Bar Road, Pleasant Valley Road and Soda Springs Road, and the addition of parking prohibitions on Boreal Ridge Road, Coyote Street, Donner Lake Road, Donner Pass Road, Maybert Road, Relief Hill Road and Washington Road be approved based on the following findings:

A. Pursuant to Article XI, Section 7 of the California Constitution, the County of Nevada (“County”) may adopt and enforce ordinances and regulations not in conflict with general laws to protect and promote the public health, safety, and welfare of its residents; and

B. Pursuant to California Vehicle Code Section 22507.5, the County may by ordinance, prohibit or restrict parking or standing of vehicles on certain streets or highways, and said ordinance will become effective after the legislative body holds a public hearing, with proper notice; and

C. Dog Bar Road, Pleasant Valley Road, Soda Springs Road, Boreal Ridge Road, Coyote Street, Donner Lake Road, Donner Pass Road, Maybert Road, Relief Hill Road and Washington Road are County maintained roadways; and

D. The County has the authority to install signs within its right of way and to enact parking restrictions as needed pursuant California Vehicle Code section 22507; and

E. That the Ordinance Amendment is needed to enable enforcement of appropriate parking restrictions to deter illegal parking; and

F. In compiling this Amendment, input was considered from California Highway Patrol, Nevada County Sheriff’s Office, Placer County, the Town of Washington Fire Department and Nevada County Staff.

#### SECTION II:

Section 3.A.8 of Article 3.A of Chapter IV of the Nevada County General Code is hereby replaced in its entirety as set forth in Exhibit A, attached hereto and incorporated herein by reference.

SECTION III:

Severability. If any provision of this Article or the application thereof to any person or circumstance is held invalid, the remainder of this Article, including the application of such part or provision to other circumstances shall not be affected thereby and shall continue in full force and effect. To this end, provisions of this Article are severable. The Board of Supervisors hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause, or phrase hereof irrespective of the fact that any one (1) or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be held unconstitutional, invalid or unenforceable.

SECTION IV:

This Ordinance shall be passed and adopted immediately after notice and a public hearing as required by statute, and shall take effect and be in force at the expiration of thirty (30) days from and after its passage, and shall become operative on the \_\_\_\_th day of July 2022, and, before the expiration of fifteen (15) days after its passage a summary shall be published once, with the names of the Supervisors voting for and against same in the Union, and in the Sierra Sun, newspapers of general circulation printed and published in the County of Nevada.
