## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING AND AUTHORIZING EXECUTION OF A PROFESSIONAL SERVICES CONTRACT BETWEEN THE COUNTY OF NEVADA AND CELESTIAL VALLEY TOWING (CVT), FOR ABANDONED VEHICLE ABATEMENT(AVA) PROGRAM AND NUISANCE PROPERTY ABATEMENT SERVICES FOR THE PERIOD JANUARY 1, 2023 THROUGH JUNE 30, 2024 IN THE AMOUNT NOT TO EXCEED \$152,500 AND THE OPTION TO RENEW THE CONTRACT FOR UP TO TWO (2) ADDITIONAL ONE (1) YEAR PERIODS AND AUTHORIZING THE AUDITOR CONTROLLER TO ENCUMBER THE CONTRACT.

WHEREAS, the Community Development Agency- Code and Cannabis Compliance Department (Department) is responsible to oversee vehicle towing services for removal of public nuisances including abandoned, wrecked, dismantled, or inoperable vehicles and related roadside services; and

WHEREAS, the Department enlisted the Purchasing Division to assist in the development of Invitation to Bid (IFB) No. 163782 for Abandoned Vehicle Abatement Towing Services; and

WHEREAS, the IFB was posted on the County's ePurchasing website inviting interested vendors to participate in responding to the solicitation; and

WHEREAS, bids were received from three firms, All American Towing Transport Inc., of Auburn, CA; Triple M Towing Inc., of Grass Valley, CA and Celestial Valley Towing (CVT) of Grass Valley, CA. and;

WHEREAS, Celestial Valley Towing (CVT) was determined to be the lowest priced firm for these services and has the appropriate licensing and certification for hauling and disposal; and

WHEREAS, the Department is also required to enforce code complaints for nuisance properties.; and

WHEREAS, CVT also has the expertise and experience to provide these abatement and disposal services; and.

WHEREAS, Purchasing Policy section 7.1(B) states Board approval is required to award a contract over \$50,000.

NOW THEREFORE, BEIT HEREBY RESOLVED the Board of Supervisors:

1. Approves the Contract and authorizes the Chair of the Board of Supervisors to execute the Contract between the County of Nevada and Celestial Valley Towing for AVA Towing and Nuisance Abatement Services in the maximum amount not to exceed \$152,500 for the initial term of 17 month beginning January 1, 2023 through June 30,2024.

2. Authorizes the Auditor Controller to encumber the contract for the maximum Fiscal Year 2022-23 portion listed in the contract:

3. Authorizes future renewals of the Contract up to two (2) additional one (1) year terms so long as the Department budget is approved at each subsequent Budget hearing and the Contract does not exceed a 10% increase.
