SUBJECT: Resolution approving execution of a renewal contract with Nevada Sierra Connecting Point Public Authority for the provision of the Californians For All Youth Service Corps Program, in the maximum amount of \$585,507, for the term of May 19, 2026, through December 31, 2027.

RECOMMENDATION: Approve the attached Resolution.

FUNDING: Funding for this agreement is from the Californians For All Youth Service Corps Program and is being presented by the Nevada County Board of Supervisors on May 19, 2026, through a separate resolution (SR 26-0259). The funding will go through December 31, 2027. There will be no General Funds required.

BACKGROUND: Youth Workforce Program is a Governor's initiative administered by California Volunteers in partnership with Nevada County and several other municipalities across California. The total amount of the Californians For All Youth Service Corps award to Nevada County is \$977,194.12, and Connecting Point is one of the subcontractors for this program. The purpose of this initiative is to increase youth employment, develop youth interest in and experience towards a career, and to strengthen county capacity to address key areas of food insecurity, climate, education, and public service. Nevada County's program will serve eastern and western county. This program will recruit, train, and place high-need youth at jobs in these key areas within our community. Nevada Sierra Connecting Point Public Authority will employ 77 youth over the life of this contract and will provide training, support, and direct supportive services to ensure best future outcomes and success of the youth served. Nevada Sierra Connecting Point Public Authority will also work in collaboration with Bright Futures for Youth and county partners to create or further develop existing partnerships with prospective employers and ensure youth in both western and eastern county have access to the YSC Program, and to assist with warm handoffs to other needed services and support.

It is recommended that the Board approve this contract.
