OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION ACCEPTING THE AMENDMENT MODIFICATION SUMMARY (E-76) AUTHORIZING ADDITIONAL FUNDING FOR THE CONSTRUCTION PHASE IN THE AMOUNT OF \$12,041.49 FOR SODA SPRINGS RD OVER THE SOUTH YUBA RIVER BRIDGE PROJECT, FEDERAL AID PROJECT #BRLO-5917(079) – DISTRICT V

WHEREAS, funds are available from the Highway Bridge Program (HBP) for the Soda Springs Road over the South Yuba River Bridge Project; and

WHEREAS, on May 27, 2014, the Board of Supervisors accepted Program Supplement N045 in the amount of \$200,000 in Preliminary Engineering funds by RES 14-193; and

WHEREAS, on August 13, 2019, the Board of Supervisors accepted an Amendment Modification Summary in the amount of \$138,750 in Preliminary Engineering funds by RES 19-450; and

WHEREAS, on October 22, 2019, the Board of Supervisors accepted Program Supplement N045 Rev 1 for a new total amount of \$438,750 by RES 19-574; and

WHEREAS, on February 23, 2021, the Board of Supervisors accepted an Amendment Modification Summary in the amount of \$1,829,250 in Construction funds by RES 21-038; and

WHEREAS, on April 13, 2021, the Board of Supervisors accepted an Amendment Modification Summary in the amount of \$36,250 in Construction funds by RES 21-100; and

WHEREAS, the State has issued an Amendment Modification Summary (E-76) authorizing an increase in the amount of the award by \$12,041.49 for the Construction phase for a total federal amount of \$2,316,291.49; and

WHEREAS, this project was accepted as complete by the Nevada County Board of Supervisors on March 8, 2022; and

WHEREAS, this amendment provides additional funding for previously unreimbursed expenses; and

WHEREAS, in order to obtain these funds, the Board of Supervisors must pass a Resolution authorizing acceptance of the increased funds; and

WHEREAS, funds should be deposited into 1114-30154-702-3000.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Accepts the Amendment Modification Summary (E-76) in the amount of \$12,041.49 for the Construction phase for a new total federal funding amount of \$2,316,291.49 for the Soda Springs Road over the South Yuba River Bridge Project.

2. Accepts Receipt of the Highway Bridge Program (HBP) funds and directs the County of Nevada Auditor-Controller to deposit said funds into:
