RESOLUTION ACCEPTING THE CALIFORNIA OFFICE OF EMERGENCY SERVICES GRANT AWARD FJ25022602 FOR THE FAMILY JUSTICE CENTER PROGRAM IN AN AMOUNT OF \$312,500 FOR A PERFORMANCE PERIOD OF APRIL 1, 2026, THROUGH MARCH 31, 2028, AND AUTHORIZING THE DISTRICT ATTORNEY, OR THEIR DESIGNEE(S) TO EXECUTE ALL REQUIRED GRANT DOCUMENTS, AND DIRECTING THE AUDITOR-CONTROLLER TO AMEND THE DISTRICT ATTORNEY'S FISCAL YEAR 2025/26 BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the Nevada County District Attorney's Office has been awarded State General Funds in the amount of \$312,500 under the California Governor's Office of Emergency Services (CalOES) Family Justice Center (FJ25) Program for the period of April 1, 2026, through March 31, 2028; and

WHEREAS, FJ25 Program funds will support the Nevada County Family Justice Center in providing legal services to victims of domestic violence, intimate partner violence, sexual assault, child abuse, elder abuse, transitional abandonment, and human trafficking, as well as assisting victims and survivors in filing petitions for protective orders, including domestic violence and gun violence restraining orders; and

WHEREAS, the District Attorney, Assistant District Attorney, and Administrative Analysts are designated as Grant Subaward Authorized Agents and are authorized to execute all required grant documents.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Board hereby accepts the CalOES FJ25 Program funds in the amount of \$312,500, for a performance period of April 1, 2026, through March 31, 2028, and authorizes the District Attorney, or their designee(s) to execute all required grant documents.

BE IT FURTHER RESOLVED that the Board of Supervisors directs the Auditor-Controller to amend the Fiscal Year 2025/26 and Fiscal Year 2026/27 District Attorney budgets, contingent upon adoption of the Fiscal Year 2026/27 Budget, as follows:
