OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION ACCEPTING AN AMENDMENT TO THE CALIFORNIA DEPARTMENT OF INSURANCE AUTOMOBILE INSURANCE FRAUD GRANT IN THE AMOUNT OF \$33,634.00 FOR THE PERIOD OF JULY 1, 2017 TO JUNE 30, 2018, RATIFYING EXECUTION OF THE AGREEMENT BY THE DISTRICT ATTORNEY AND APPROVING A RELATED BUDGET AMENDMENT (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the Nevada County District Attorney's Office applied for and has been awarded Automobile Insurance Fraud Grant Funds by the California Department of Insurance; and

WHEREAS, an amended award for Automobile Insurance Fraud Grant Funds in the amount of \$1,817.00 have been made available for the period of July 1, 2017 to June 30, 2018 for a total award of \$33,634.00; and

WHEREAS, the Nevada County Board of Supervisors desires to maintain an Automobile Insurance Fraud program through funds administered by the California Department of Insurance; and

WHEREAS, any liability arising out of performance of Grant Award Agreement, including civil court actions for damages is the responsibility of the grant recipient and the authorizing agency; and

WHEREAS, the Grant funds received hereunder may not be used to supplant existing expenditures controlled by this body; and

WHEREAS, the District Attorney executed an Agreement regarding the acceptance and use of the Grant Funds on November 6, 2017.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Nevada hereby accepts additional Automobile Insurance Fraud Grant Funds in the amount of \$1,817.00 for use from July 1, 2017 to June 30, 2018 to investigate and prosecute automobile insurance fraud and economic car theft cases.

BE IT FURTHER RESOLVED that the Board of Supervisors hereby ratifies the District Attorney execution of the Amendment to the Grant Agreement, effective as of November 6, 2017, and authorizes the District Attorney to execute all payment requests and related documentation necessary to secure the grant funds.

BE IT FURTHER RESOLVED that all Automobile Insurance Fraud Grant Funds received shall be deposited into District Attorney Revenue Account 0101 20103 101 1000 445090 and that the Fiscal Year 2017/18 budget is hereby amended to increase the following revenue and expenditure accounts as follows:

Automobile Insurance Fraud Program



The Insurance Commissioner of the State of California hereby makes an amendment to the award of funds to **Nevada County**, Office of the District Attorney, in the amount and for the purpose and duration set forth in this grant award.

This amended grant award consists of this agreement and the application for the grant and made a part hereof. By acceptance of the amended grant award, the grant award recipient agrees to administer the grant project in accordance with all applicable statutes, regulations and Request-for-Application (RFA).

Duration of Amended Grant: The grant award is for the program period, **July 1, 2017** through **June 30, 2018**.

Purpose of Amended Grant: This grant award is made pursuant to the provisions of California Insurance Code §1872.8 and shall be used solely for the purposes of enhanced investigation and prosecution of automobile insurance fraud and economic car theft cases.

Amount of Amended Grant: The grant award agreed to herein is in the amount of **\$33,634** which is an increase of **\$1,817** above the initial funding amount. This amount has been determined by the Insurance Commissioner. However, the actual total award amount for the county is contingent on the collection and the authorization for expenditure pursuant to the Government Code §13000 et seq. The grant award shall be distributed pursuant to §1872.8 of the Insurance Code and to the California Code of Regulations Sub-Chapter 9, Article 4, §2698.65.
