OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AMENDMENT NO. A04 TO THE RENEWAL STANDARD AGREEMENT NUMBER 14-90076 WITH THE CALIFORNIA DEPARTMENT OF HEALTH CARE SERVICES (DHCS) FOR FUNDING SUBSTANCE USE DISORDER (SUD) SERVICES (RES. 14-507; RES. 15-200; RES. 15-441 AND RES. 16-085)

WHEREAS, the California Department of Health Care Services contracts with counties for the provision of alcohol and drug prevention and treatment services in their service areas; and

WHEREAS, per Resolution 14-507, the Nevada County Board of Supervisors approved the three-year renewal Agreement Number 14-90076, which provides Federal Substance Abuse Prevention and Treatment (SAPT) Block Grant funding and reimbursement for allowable Drug Medi-Cal services provided to clients for the term of July 1, 2014 through June 30, 2017; and

WHEREAS, per Resolution 15-200, the Nevada County Board of Supervisors approved Amendment A01 to said Agreement which increased the funding for Fiscal Year 2014/15; and

WHEREAS, per Resolution 15-441, the Nevada County Board of Supervisors approved Amendment A02 to said Agreement which increased the funding for Fiscal Year 2015/16; and

WHEREAS, per Resolution 16-085, the Nevada County Board of Supervisors approved Amendment A03 to said Agreement which increased the funding for Fiscal Year 2015/16; and

WHEREAS, the County is in receipt of Amendment No. A04 to the Agreement which increases the funding for Fiscal Year 2016/17 for alcohol/drug dependency treatment and preventive services for county residents.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that Amendment No. A04 to Standard Agreement Number 14-90076 by and between the County and the California Department of Health Care Services which provides funding for substance use disorder services for the term of July 1, 2014 through June 30, 2017, which increases the maximum payable amount for Fiscal Year 2016/17 to \$1,037,452, revising the total maximum amount from \$2,940,644 to \$3,123,131 (an increase of \$182,487) for the entire contract term, be and hereby is approved in substantially the form hereto attached, and that the Chair of the Board of Supervisors be and is hereby authorized to execute Amendment No. A04 to the Agreement on behalf of the County of Nevada.
