OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING EXECUTION OF AMENDMENT 1 TO THE REVENUE AGREEMENT WITH THE COUNTY OF SIERRA FOR THE PROVISION OF TELEPHONE TRIAGE SERVICES FOR SIERRA COUNTY ADULT SYSTEM OF CARE AND CHILDREN'S SYSTEM OF CARE TO CHANGE THE REFERRAL AND DOCUMENTATION PROCESSES AND TO INCREASE THE CONTRACT AMOUNT BY \$6,000 TO \$28,992 FOR THE TERM OF JULY 1, 2024, THROUGH JUNE 30, 2025

WHEREAS, on August 6, 2024, per Resolution 24-418, the Nevada County Board of Supervisors approved execution of an Agreement with the County of Sierra to enter into a mutually beneficial arrangement whereby Nevada County Behavioral Health agrees to provide telephone triage services for Sierra County Adult System of Care (ASOC) and Children's System of Care (CSOC) with regard to mental health referrals for children, youth, and adults, as well as telephone answering services for after-hours CSOC child welfare calls and emergency calls; and

WHEREAS, the parties wish to change the referral process to reflect the use of the Sierra County Behavioral Health Access Contact or the Sierra County on call crisis worker and Dispatch of Sierra County Mobile Crisis Response Team from Plumas County Behavioral Health Access and Plumas On Call resources, as well as to be the call center for FSP clients and triage, this amendment also reflects calls and services to be documented into the Sierra County Electronic Health Record (HER), Credible.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Amendment No. 1 to the Agreement for Services by and between the County of Nevada and County of Sierra pertaining to Nevada County Behavioral Health Department providing telephone triage services for the Sierra County Adult System of Care and Children's System of Care, for a total contractual obligation not to exceed \$28,992 (an increase of \$6,000) for the term of July 1, 2024 through June 30, 2025, be and hereby is approved in substantially the form attached hereto, and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.
