OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING THE EXECUTION OF AMENDMENT NO. 1 TO THE AGREEMENT WITH CROW'S NEST RANCH OUTPATIENT, LLC., FOR THE PROVISION OF OUTPATIENT INDIVIDUAL AND GROUP REHABILITATIVE TREATMENT SERVICES, AND RECOVERY SERVICES FOR MEDI-CAL MEMBERS FOR THE RECOVERY AND TREATMENT OF ALCOHOL/DRUG DEPENDENCY, TO INCREASE THE MAXIMUM CONTRACT PRICE FROM \$100,000 TO \$220,000 (AN INCREASE OF \$120,000), AND REVISE EXHIBIT "B" SCHEDULE OF CHARGES AND PAYMENTS TO REFLECT THE INCREASE IN THE MAXIMUM CONTRACT PRICE FOR THE CONTRACT TERM OF SEPTEMBER 23, 2025, THROUGH JUNE 30, 2026 (RES. 25-514)

WHEREAS, on October 28, 2025, through Resolution 25-514, the Nevada County Board of Supervisors authorized execution of the professional services contract with Crow's Nest Ranch Outpatient, LLC., for the provision of outpatient individual and group rehabilitative treatment services and recovery services for Medi-Cal members, for the recovery and treatment of alcohol/drug dependency; and

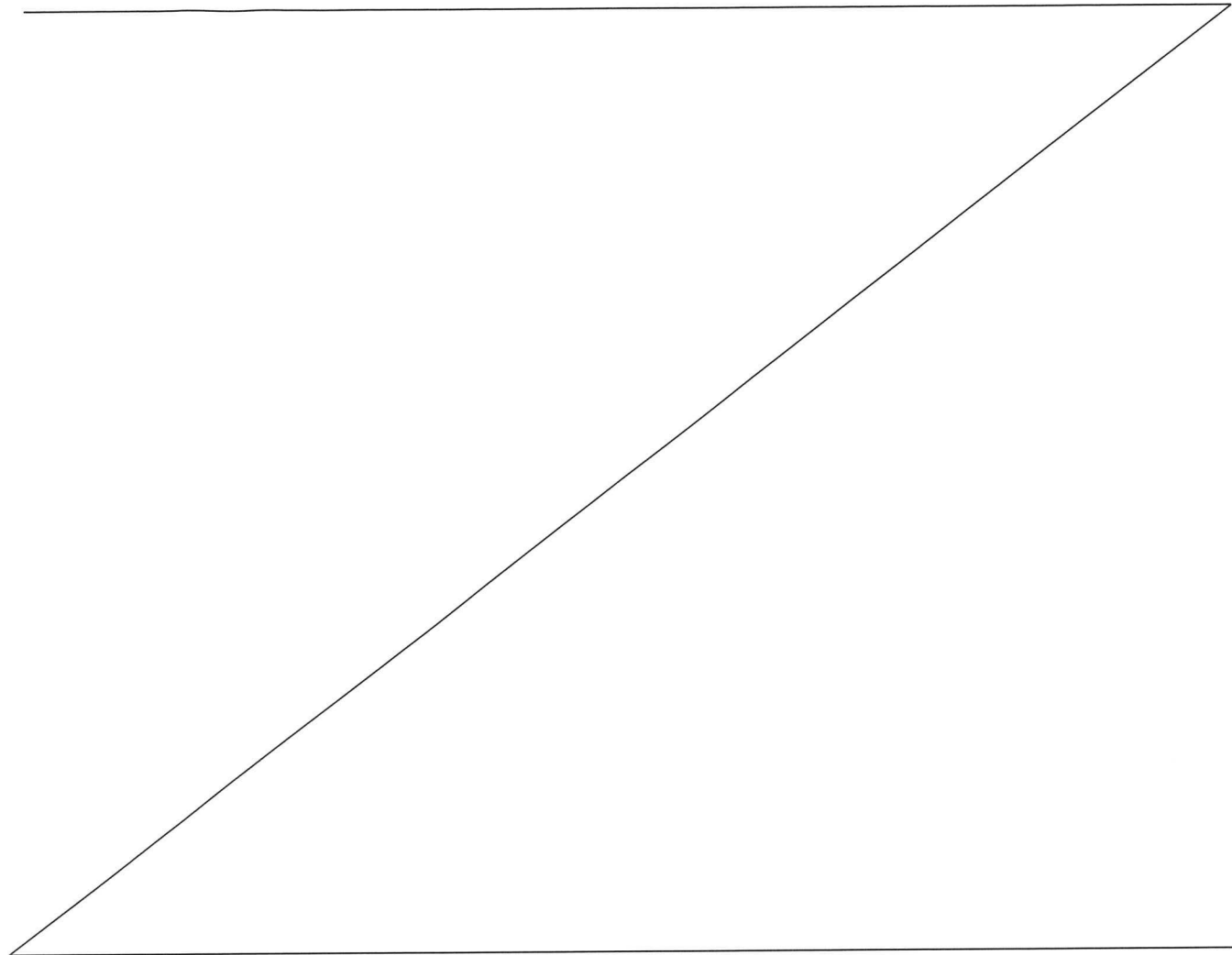
WHEREAS, Crow's Nest Ranch Outpatient, LLC., is a non-profit organization licensed by the State to provide services for the treatment of substance use disorders; and

WHEREAS, Crow's Nest Ranch Outpatient, LLC., provides Outpatient Drug Free and Intensive Outpatient Treatment for the recovery of substance use disorders to residents of Nevada County; and

WHEREAS, under this agreement, the Crow's Nest Ranch Outpatient, LLC., (Contractor), has provided comprehensive substance use disorder services for youth and adult County members; and

WHEREAS, the parties desire to amend their Agreement to increase the contract price from \$100,000 to \$220,000 (an increase of \$120,000), and amend Exhibit "B" Schedule of Charges and Payments to reflect the increase in the maximum contract price.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Amendment No. 1 to the contract by and between Nevada County and Crow's Nest Ranch Outpatient, LLC., pertaining to the provision of Outpatient Drug Free and Intensive Outpatient Treatment, for substance use disorder treatment to residents of Nevada County, for the contract term of September 23, 2025, through June 30, 2026, in the maximum amount of \$220,000, be and hereby is approved, and the Chair of the Board of Supervisors be and is hereby authorized to execute the Amendment on behalf of the County of Nevada.
