SUBJECT: Resolution authorizing the Chair of the Board to sign the Invitation to Bid and authorizing the Purchasing Agent to solicit bids for the 2024 Road Rehabilitation Project, County Project Number 450012, Districts I, III and IV

RECOMMENDATION: Adopt the attached Resolution authorizing the Chair of the Board to sign the Invitation to Bid and authorizing the Purchasing Agent to solicit bids for the 2024 Road Rehabilitation Project.

FUNDING: The 2024 Road Rehab Project will be paid for with Road Maintenance and Rehabilitation Account (RMRA) funds, and funds from County Service Area (CSA) 24 Zone 1, CSA 24 Zone 2, and Permanent Road Division (PRD) Long Valley Road, there is no impact to the General Fund. The project is included in the FY 2023/24 Capital Improvement Program for Road Engineering. An amendment for FY 2023/24 may be required in all four funds to award and encumber the full contract in FY 2023/24.

BACKGROUND: On February 27, 2024, the Nevada County Board of Supervisors approved Resolution No.24-0180 an environmental clearance for pavement rehabilitation along multiple county-maintained roads, two CSA locations, and one PRD location.

The Department of Public Works is proposing to rehabilitate approximately 18.25 miles of roadway using a combination of asphalt repairs, and resurfacing as shown on Attachment A. The Director of Public Works (or Interim Director) may make adjustments to the roadways listed as necessary.

The project specifications and cost estimate for this project have been completed. The Engineer's estimate is \$1,355,000.00, plus a 10% contingency of \$135,500.00 for a total not to exceed contract of \$1,490,500.00.

The bid opening date will be set by the Director (or Interim Director) of Public Works, with construction scheduled to begin in the summer of 2024.
