

**NEVADA COUNTY BOARD OF SUPERVISORS
IS SEEKING INTERESTED PERSONS TO SERVE ON THE FOLLOWING:**

***ADULT AND FAMILY SERVICES COMMISSION:** (5 vacancies) One Low-Income Sector vacancy to fill an unexpired term ending April 30, 2019, and four Private Sector vacancies; two to fill 2-year unexpired terms ending April 30, 2019, and two to fill 2-year unexpired terms ending April 30, 2020. This Commission shall operate under the Nevada County Board of Supervisors as the primary advisory body relative to health and human service's needs, and performs the responsibilities of the Board of Directors as described under Title 42 USC Chapter 106 § 9910 - Tripartite Boards. ***AGRICULTURAL ADVISORY COMMISSION:** (1 position) One Agricultural Interests representative to fill a 4-yr. term unexpired term ending March 30, 2019. The Commission shall advise the Board of Supervisors on matters concerning the agricultural resources of the County, develop a framework for cooperation among agencies and institutions, interest groups, individuals, public and private property owner, and all others for wise conservation and management of resources to benefit the County's agricultural assets, and maintain an active Agricultural Commission to advise the County on agricultural-related matters. ***ASSESSMENT APPEALS BOARD:** (1 vacancy) One alternate member to fill an unexpired 1-year term ending September 30, 2019. Specific qualifications are required per Section 1624 of the Revenue and Taxation Code. The function of the Appeals Board is to determine the full value of property or to determine other matters of property tax assessment over which the Appeals Board has jurisdiction. The Board acts in a quasi-judicial capacity and renders its decision only on the basis of proper evidence presented at the hearing. The functions of the Board are outlined in Section 1620 et seq. of the Revenue and Taxation Code. Compensated per Administrative Code Chapter II, Article 13.11. ***KINGSBURY GREENS COMMUNITY SERVICES DISTRICT:** (1 vacancy) One resident of Kingsbury Greens CSD to fill an unexpired term ending December 4, 2020. The District shall provide for the collection, treatment, and disposal of sewage, waste and storm water of the district and its residents. Applications must be submitted to Nevada County Clerk of the Board. Must be a registered voter in the District. MENTAL HEALTH ADVISORY BOARD: (3 vacancies) One vacancy for a District IV representative and one for a District V representative, both positions to fill unexpired 3-year terms ending June 30, 2020; and one vacancy for a District I representative to fill an unexpired 3-year term ending June 30, 2019. This Board reviews and evaluates the community's mental health needs, services, facilities, and special problems; reviews any County agreements entered into pursuant to Welfare and Institutions Code Section 5650; advises as to any aspect of the local mental health program; reviews and approves the procedures used to ensure citizen and professional involvement at all stages of the planning process; and submits an annual report to the Board of Supervisors. MUNICIPAL ADVISORY COUNCIL (PENN VALLEY AREA) (MAC): (2 vacancies) Two member vacancies available January 01, 2019, to fill unexpired 2-year terms ending June 30, 2019. The Municipal Advisory Council (MAC) for the Penn Valley Area consists of seven (7) regular members and two (2) alternate members appointed by the District IV Supervisor and serve at the pleasure of the District IV Supervisor and the Board of Supervisors. Members are required to reside within Supervisorial District IV boundaries that are within either the Western Gateway Regional Recreation and Park District or the Penn Valley Fire Protection District (MAC boundaries). The Council meets at least quarterly or more often as deemed necessary by the Council, District IV Supervisor or the Board of Supervisors. NEVADA COUNTY SANITATION DISTRICT NO. 1 ADVISORY COMMITTEE:

(7 vacancies) One Lake of the Pines Zone 2 representative position, one Lake of the Pines Zone 2 alternate position, one Gold Creek Zone 5 representative and one Penn Valley Zone 6 representative position, all to fill unexpired 2-year terms ending June 30, 2020; one Cascade Shores Zone 8 representative, one Cascade Shores Zone 8 alternate, and one Eden Ranch Zone 9 representative, all to fill 2-yr. unexpired terms ending June 30, 2019. ***SEWAGE DISPOSAL TECHNICAL ADVISORY GROUP:** (4 vacancies) One consultant appointed by District II Supervisor, one consultant appointed by District IV Supervisor, and one consultant appointed by District V Supervisor, each selected from the County-at-large to serve at the pleasure of the appointing Supervisor. One Realtor representative appointed by the Board of Supervisors to serve at the pleasure of the Board. Consultant is defined in County of Nevada On-Site Sewage Disposal Ordinance 1975 as one of the following; Certified Engineering Geologist, Certified Professional Soil Scientist, Registered Civil Engineer, Registered Environmental Health Specialist, or Registered Geologist. Said group members may not be employees of the County of Nevada. Each group member will be qualified by experience and training to pass on matters pertaining to sewage disposal. The purpose will be to review and recommend proposed revisions and additions to the sewage disposal regulations or sewage disposal ordinance in an advisory capacity; review and recommend new methods, techniques, and materials for on-site sewage disposal, in an advisory capacity; and serve as an appeal body under the provisions of Section A-032 of County Resolution 98-217. ***SOLID AND HAZARDOUS WASTE COMMISSION (NEVADA COUNTY):** (2 vacancies)
