SUBJECT: Reappointment of Superintendent Scott Lay as member representing the interests of local school districts for a two-year term ending February 28, 2024, and reappointment of Laura Brown as member representing the interests of children in the Greater Truckee area for two-year term ending October 31, 2023, to the First 5 Nevada County Children & Families First Commission

RECOMMENDATION: Approve reappointment of Superintendent Scott Lay and Laura Brown to the First 5 Nevada County Children & Families First Commission. Laura Brown to the position as the Greater Truckee Area Member representing the interests of children for a two-year term ending October 31, 2023 and Superintendent Scott Lay to the First 5 Nevada County Children & Families First Commission as the member representing interests of local school districts for a two-year term ending February 28, 2024.

BACKGROUND:

Currently, there are two positions available on the First 5 Nevada County Children & Families First Commission. One for member representing the interests of local school districts position for a two-year term beginning on March 1, 2022 and ending on February 28, 2024. The second position is for a member representing the interests of children in the Greater Truckee area for an unexpired 2-year term ending October 31, 2023. These positions were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers Bulletin Board, the Board of Supervisors office, and the County website. Notice was also posted at the Truckee Town Hall, and the District V Board of Supervisors office in Truckee.

Laura Brown submitted an application for reappointment on January 20, 2022, for the member representing the interests of children in the Greater Truckee area. Laura was first appointed to the position on November 12, 2013, and was subsequently reappointed in 2015, 2017 and 2019. She is currently a member in good standing.

Superintendent Lay submitted an application for reappointment on January 21, 2022 to the position member representing the interests of local school districts. He was first appointed to the position on August 28, 2018, and was subsequently reappointed in 2020. He is currently a member in good standing.
