

# OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZING A NEW CAPITAL LEASE OF A PITNEY BOWES SEND PRO MAIL CENTER DIGITAL MAILING SYSTEM FOR A TERM OF 1/1/2025 THROUGH 12/31/2029 IN THE AMOUNT OF \$43,990.20 AND AMENDING THE CENTRAL SERVICES FISCAL YEAR 2024/25 BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the Nevada County Central Services Division has the responsibility to provide mail services for County departments totaling over 100,000 pieces of metered mail annually; and

WHEREAS, Resolution 20-273, passed June 2020, approved a five-year capital lease and maintenance agreement with Pitney Bowes which expires June 30, 2025; and

WHEREAS, United States Postal Service has issued a new mandate effective June 30, 2025, all Information Based Indicia (IBI) meter technology is discontinued and being replaced by Intelligent Mail Indicia (IMI) solution. As our current Send Pro P Series runs on IBI it will need to be replaced prior to the June 30, 2025 deadline; and

WHEREAS, through review of available products it was found that the increased capabilities of the SendPro Mail Center Digital Mailing System will offer continued savings to County departments through bulk pricing, bar coding and package mail discount; and

WHEREAS, both parties wish to enter into a new five-year capital lease agreement which includes subscriptions and maintenance.

NOW, THEREFORE, BE IT HEREBY RESOLVED, that the Board of Supervisors of the County of Nevada, California, by a four-fifths affirmative vote:

- 1. Authorizes procurement of a Pitney Bowes SendPro Mail Center Digital Mailing System through a five-year capital lease for the term of January 1, 2025, through December 31, 2029, in the amount of \$43,990.20 (\$8,798.04 annually).
- 2. Authorizes the Purchasing Agent to execute the lease and encumber the funds.
- 3. Authorizes the Auditor-Controller to amend the Fiscal Year 2024/25 Central Services budget as follows:




