### RESOLUTION APPROVING A NOTICE OF ACCEPTANCE AND COMPLETION FOR THE ELECTRIC BUS CHARGING PROJECT TINLOY STREET TRANSIT CENTER - COUNTY PROJECT NO. 889830-10 – DISTRICT III


WHEREAS, the County of Nevada entered into an agreement with REM Construction, Incorporated by Resolution 25-145 for a contract totaling \$801,204.09 plus a 10% contingency of \$80,120.41 for the contract work items, for a total of \$881,324.50; and

WHEREAS, said Contract for the Electric Bus Charging Project Tinloy Street Transit Center was completed in accordance with the plans and specifications; and

WHEREAS, the improvements were completed to the satisfaction of the Nevada County Department of Public Works on November 15, 2025, with contract costs totaling \$809,220.36.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

1. Accepts the work as being completed.
2. Directs the Clerk of the Board of Supervisors to release the Bond for Labor and Materials on January 20, 2026, and the Bond of Faithful Performance on December 16, 2026.
3. Directs the Clerk of the Nevada County Board of Supervisors to record this notice in accordance with Civil Code Section 9208.
