OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION ACCEPTING THE AMENDMENT MODIFICATION SUMMARY (E-76) INCREASING THE AUTHORIZED FUNDING FOR PRELIMINARY ENGINEERING BY \$25,000, RIGHT OF WAY BY \$74,913 AND OTHER BY \$172,229 FOR FEDERAL AID PROJECT NUMBER BRLO 5917(092) HIRSCHDALE RD OVER TRUCKEE RIVER BRIDGE PROJECT – DISTRICT V

WHEREAS, funds are available from the Federal Highway Bridge Program for the Hirschdale Road Over Truckee River Bridge Project; and

WHEREAS, on April 12, 2016, the Board of Supervisors accepted Program Supplement F056 in the amount of \$538,800 in Preliminary Engineering funds by Resolution 16-151; and

WHEREAS, on August 11, 2020, the Board of Supervisors accepted an additional \$50,000 in Right of Way funds and \$20,000 in Other by Resolution 20-363; and

WHEREAS, on June 28, 2022, the Board of Supervisors accepted Program Supplement F056 Revision 1 in the amount of \$121,200, with \$31,200 allocated for Preliminary Engineering and \$90,000 for Right of Way by RES 22-321; and

WHEREAS, on January 10, 2023, the Board of Supervisors accepted an additional \$150,000 in Right of Way funds by Resolution 23-018; and

WHEREAS, the State has issued an Amendment Modification Summary (E-76) authorizing the increase of the award by \$25,000 for Preliminary Engineering, \$74,913 for Right of Way and \$172,229 for Other for a total Project award amount of \$1,152,142; and

WHEREAS, in order to receive these additional funds, the Board of Supervisors must pass a Resolution authorizing acceptance of the funds; and

WHEREAS, funds should be deposited into Road Capital Improvement Budget Account 1114-30154-702-3000 / 446370.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors:

- 1. Accepts the Amendment Modification Summary (E-76) in the amounts of \$25,000 for Preliminary Engineering, \$74,913 for Right of Way and \$172,229 for Other for a new total Federal funding amount of \$1,152,142 for the Hirschdale Road Over Truckee River Bridge Project.
- 2. Accepts Receipt of the additional Federal funds and directs the County of Nevada Auditor-Controller to deposit said funds into Budget 1114-30154-702-3000 / 446370.
