## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING THE PURCHASE OF FURNITURE FOR THE GENE ALBAUGH COMMUNITY ROOM LOCATED WITHIN THE MADELYN HELLING LIBRARY BRANCH, IN THE AMOUNT OF \$27,276 AND DIRECTING THE AUDITOR CONTROLLER TO AMEND THE FISCAL YEAR 2025/26 LIBRARY BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, Nevada County Library intends to purchase chairs and tables for the Gene Albaugh Community Room at the Madelyn Helling Library Branch; and

WHEREAS, the new furniture will replace the current chairs and tables, which are showing significant signs of wear; and

WHEREAS, the new furniture will improve the experience for the patrons renting the Gene Albaugh Community Room; and


WHEREAS research by the Purchasing Department has concluded that Walker's offers competitive pricing for seventy chairs, twelve tables, and a storage dolly in the amount of \$27,276.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California that the purchase of furniture and storage dolly be approved and the Auditor-Controller is directed to release Library fund balance in the amount of \$27,276 and amend the Fiscal Year 2025/26 Library Budget as follows:
